This Cookie Policy explains how Everytrade24 Ltd uses cookies and similar technologies in connection with the operation of its website and online services. Certain cookies are technically required to ensure the security and basic functioning of our website. For analytics and marketing cookies, we will always obtain your explicit consent before they are set.

1. Introduction

Everytrade24 Ltd (“the Company”) is a financial services provider incorporated in Mauritius with its registered office at Office 306, 3rd Floor, Ebene Junction, Rue De La Democratie, Ebene 72201, Republic of Mauritius. The Company is licensed and supervised by the Financial Services Commission (FSC), Mauritius.

This Cookie Policy explains what cookies are, how and why we use them, and what rights and options you have as a user. For clients residing in Switzerland, the provisions of the Federal Act on Data Protection (FADP) apply, in addition to the EU General Data Protection Regulation (GDPR), where applicable.

2. What Are Cookies?

Cookies are small text files that are stored on your device when you access our website. They enable essential functions, store preferences, and help us understand how users interact with our website in order to improve usability, performance, and security.

3. Categories of Cookies and Legal Basis

We use the following categories of cookies:

- **Strictly Necessary Cookies**
These cookies are required for the operation and security of the website, such as login sessions, form completion, or fraud prevention. They are based on Article 6(1)(b) GDPR (contract performance) and Article 31(1) FADP (processing necessary for contract performance).
- **Functional Cookies**
These cookies remember user preferences (such as language or region) and ensure a more personalized experience. They are based on legitimate interests (Article 6(1)(f) GDPR; Article 31(1) FADP).
- **Analytics and Performance Cookies**
These cookies help us analyze website traffic and improve functionality, for example through tools such as Google Analytics. They are only used with your prior consent (Article 6(1)(a) GDPR; Article 6(6) FADP for profiling).
- **Marketing and Targeting Cookies**
These cookies are used to deliver personalized advertising and measure the

effectiveness of marketing campaigns. They are set exclusively with your explicit consent (Article 6(1)(a) GDPR; Article 6(6) FADP for targeted advertising).

4. Storage Location and Retention

Cookies are generally stored in your browser. Session cookies are automatically deleted when you close your browser, while persistent cookies remain stored until their expiry date or until you delete them manually.

All personal data collected through cookies is processed in secure data centers operated by our hosting partners in Switzerland and/or the European Union, ensuring compliance with applicable data protection standards.

5. Managing Cookies and Withdrawing Consent

You may disable or delete cookies at any time through your browser settings. Please note that disabling strictly necessary cookies may affect the functionality of the website.

Analytics and marketing cookies will only be set with your explicit consent (“opt-in”). You may withdraw this consent at any time with future effect, for example by using the “Cookie Settings” link in the footer of our website.

6. Third-Party Cookies

Some third-party providers, such as Google, Meta, or payment processors, may set their own cookies when you interact with our website. These providers act independently and are responsible for their own processing activities under their respective privacy policies. We require them, through contractual agreements, to comply with applicable data protection standards under GDPR and FADP.

We may update this Cookie Policy from time to time to reflect changes in technology, applicable law, or our business practices. The latest version will always be available on our website.
