



Prize Draw Terms and Conditions

 - Complete the survey in full (i.e. complete each section of the Survey); and
 - Opt-in to the prize draw relating to the Survey.

The Curiosity Company will take all reasonable steps to remove your data from the survey and handle your personal information in accordance with The Curiosity Company's Privacy Policy that aligns with the Privacy Act 2020.
