Evaluation Methods Used

The accessibility assessment was conducted by manual review and keyboard navigation testing in a Chromium browser. Scenarios were tested using:

- Keyboard-only interaction across all steps of the questionnaire, including tabbing forward and backward through form fields and controls.
- VoiceOver with Google Chrome to verify that form elements expose appropriate roles, names and values.
- The AXE accessibility testing extension to check for colour contrast issues and missing ARIA labels.
- The WAVE Colour Contrast Analyzer to measure text-to-background contrast ratios.
