- CONTRACTOR MEMBER** - Annual Membership Dues are \$2,400.00  
 Includes all prime and subcontractors. Contractor members are also subject to percentage dues of any contract or subcontract awarded by FDOT, Airport or Expressway work, and is calculated as follows. The first \$25 million of total work is billed at 1/10th of 1% with the exception of the first \$2.4 million of total work is exempt from such calculations. Total work over \$25 million will be billed at 1/100th of 1%. The total annual dues are capped at \$50,000. Contracts of hand or awaiting award at the time of joining are not included in the calculations.

- ASSOCIATE MEMBER** - Annual Membership Dues are \$3,000.00  
 Includes equipment dealers, material suppliers, engineering firms and design consultants. Material is defined as any item used in the actual construction of a project. Any other firm or individual with an interest in the transportation industry, except prime contractors and subs, are included in the associate member category.

- AFFILIATE MEMBER** - Annual Membership Dues are \$1,000.00  
 If you do not fall into either of the above categories but have an interest in providing goods and services not utilized in the actual construction of a project, to those in the industry you would be an affiliate member. Attorneys, CPA's, insurance agents, bonding firms and individual claims consultants would fall under this category.
