Overview of VCU Labels & Introduction to Certification Labels

VCU Labels

- A VCU (Verified Carbon Unit) label indicates that a unit meets the requirements of other (non-VCS) standards programs or is eligible/qualifies to be traded in specific markets.
- A VCU can be associated with multiple labels, enhancing its market value and recognition.
 - Certification Labels: These indicate that a unit meets the requirements of other (non-VCS) standards or programs developed by non-profit or governmental organizations.
 - Upon submission of the required documentation to the Verra Registry, certification labels can be applied to VCU's if units conform with the requirements from the approved standards.

W+ Label



The W+ Label

- The W+ label signals that a VCS project conforms with the requirements of the W+ Standard. W+ is a certification framework developed by WOCAN - Women Organizing for Change in Agriculture and Natural Resource Management.
- Provides metrics to quantify, verify, and monetize women's empowerment results within projects and supply chains.
- W+ label for VCUs are active and available on the Verra Registry.
- Projects that follow each program's respective registration, validation, and verification requirements are eligible to receive W+ labeled Verified Carbon Units (VCUs).
- The W+ Label Guidance Document, released on June 25, 2024, provides guidance for project proponents registering their projects with both the Verified Carbon Standard (VCS) Program and the W+ Standard who wish to receive the label.

Importance of W+ labeled VCUs

For Project Developers:

- provides design framework for integrating women's empowerment activities into carbon projects
- provides financial incentive to expand activities of benefit to women
- meets increasing demand of buyers for high integrity, social impacts and benefits to communities
- avoids headline risk of 'pink washing' - making claims about women's empowerment that are not backed by evidence and third-party verification

For Buyers of VCUs:

- provides high-quality carbon credits with gender co-benefits that go beyond 'box-checking' and self-reporting
- addresses need for the "S" as well as the "E" of ESG, fulfills commitments to SDG 5
- provides transparent way to directly support local women and their organizations

Background: W+ Program

What it is: standard/certification framework that provides metrics and procedures to quantify, verify and monetize women's empowerment results within projects and supply chains, in relation to 6 domains.

What it Does: provides framework for **designing** as well as **monitoring results within projects** and generates W+ credits - quantified and verified units of improvement in women's conditions from a baseline in one or more of six domains. Labels are for specific domains.

1 W+ credit = 10% impact for one woman within the monitoring period.

Sharing value with women: At least 20% of the revenue from W+ credit sales is granted to women's groups to be utilized as they see best fit to address community and climate adaptation needs and opportunities.



Process for W+ certification



Develop Project Idea Note (PIN)

The Project Developer presents information about the project activities for women's empowerment, number of women impacted, and other project data.

Draft selections for which W+ domain are determined in discussions with the W+ Coordinator.

The PIN is submitted to the W+ Coordinator

PIN is approved by the W+ Coordinator

Project is registered on W+ website.

Project Design Document (PDD)

Conduct stakeholders' consultations and a gender analysis in the project site to select the W+ domains and indicators, and if needed, develop or make adjustments to the Gender Action or Women's Empowerment Action Plan.

Develop a draft Monitoring and Evaluation Plan for implementation of activities and W+ measurement

Determine mechanism for benefit sharing with local women

Prepare the draft PDD

W+ Coordinator approves PDD

The project developer will adjust the PDD if needed and submit it to the W+ Coordinator

Prepare for and conduct baseline survey

Prepare the detailed questionnaires specific to each selected domains for use in the baseline and monitoring data collection

* Process includes determining the sample size and training local women enumerators

The baseline survey will then be conducted by enumerators and data analysed with the help of a statistician

Measure results & prepare a Monitoring and Results report

Measure the results using same questionnaires and trained enumerators.

Prepare a draft Monitoring and Results Report.

Project developer approves the report and sends it directly to the verifying body.

Verifier's report is used to issue W+ credits to Project Developer, which are placed in W+ registry.

Eligibility Criteria

W+ Label Eligibility Criteria

- Any VCS (including joint VCS and CCB Program) project that conforms with the VCS Program and W+ Standard requirements is eligible to receive W+ labeled VCUs.
- Projects must have valid W+ certification for the entire verification period for which VCUs are being requested.
- VCUs that have already been issued may be retroactively labeled where the entire batch would receive the same type of W+ label, and where the W+ Coordinator confirms that the W+ certification is valid for the entire verification period of the issued VCUs.

Eligible VCUs

1) The W+ Standard has specific rules for how many VCUs may receive a W+ label within a VCS project. These rules are in the W+ Standard Guidance Document.

1) The available W+ labels will depend on the **type of project activities**. They are:

- W+ Knowledge & Education
- W+ Health
- W+ Leadership
- W+ Food Security
- W+ Income & Assets
- W+ Time

There are **two ways** that the W+ Standard may be used to generate VCU labels, depending on the number of women beneficiaries in the project area:

- 1) 100% W+ labeling for all VCUs generated
- 2) A subset of VCUs labeled, based on the percentage of women beneficiaries from the total population of women in the project area

Examples:

- 1) Cookstove or biogas project wherein almost all women within the project are benefiting, so a 1:1 labeling for carbon credits
- 2) Forestry project where 20% of women are benefitting from improved access to non timber forest products, so 20% of carbon credits receive W+ label

Process Overview

Process for Applying W+ Labels

- The registration and issuance processes are handled independently by each program.
- Projects can demonstrate simultaneous registration under both programs.

At VCS Program Registration

Project proponents must submit to the Verra Registry:

- 1) All required VCS Program documentation (see the *VCS Program Registration and Issuance Process*)
- 2) W+ Project Idea Note (PIN)
- 3) W+ Project Design Document (PDD)

At VCS Program Verification Approval

Project proponents must submit the following to request verification approval:

- 1) All required VCS Program documentation (see the *VCS Program Registration and Issuance Process*)
- 2) W+ Monitoring and Results Report
- 3) W+ Verification Report

Applying for W+-labeled VCUs from the Verra Registry

- When preparing the issuance request, you may request the label by selecting the relevant W+ label from the “Additional Certifications” page on the Verra Registry.
- If the same W+ domain label does not apply to the entire verification period, please contact registry@verra.org for assistance to make the label request.
- The Verra Registry then confirms with the W+ Coordinator:
 - 1) That the W+ certification is valid for the entire period for which VCUs are being requested,
 - 2) The quantity of VCUs that are eligible for the W+ label, and
 - 3) The type of W+ labels that may be applied to the VCUs.

Verra Registry Label Requests

- Account Holders may request the new labels be added to their issuance request through the Verra Registry under 'Additional Certifications' on the project's Verification Summary page.
