Brief narrative description of the project location	Cameroon's mangrove ecosystems constitute a reservoir of exceptionally varied biodiversity and are considered among the most productive in the Gulf of Guinea. They occupy an area of 232,723 ha (Cam-Eco, 2014). They are among the largest in Africa and thus occupy the 6th position (UNEP, 2007). Cameroon's maritime coastline extends from 2°20' (border with Equatorial Guinea) to 4°40' north latitude (Akwayafé River, border with Nigeria). These mangrove ecosystems are concentrated in three large areas classified in descending order according to the area, namely: (1) the Rio Del Rey area (128,900 ha); (2) the Cameroon Estuary (102,249.36 ha) and (3) the Rio Ntem area, extending from the mouth of the Nyong to the Ntem River (1,573.54 ha). Mangroves fulfill multiple functions and are of capital importance from a biological, ecological, environmental, economic and social point of view. Three reasons justify the choice of these districts: (1) their proximity to the ports where mangrove fuelwood is unloaded, (2) the concentration of women who smoke fish in these districts and (33) the impoverishment of households whose main source of energy used for cooking meals is mangrove fuelwood. Manoka is the largest island in Cameroon and the capital of the Douala 6th district. Located 35 minutes off the small fishing port of Youpwé, it is inhabited by a mosaic of local and foreign communities with a strong Nigerian community. This island has 11 fishing camps and its inhabitants live mainly from fishing and smoking fish. Due to the lack of electricity, most women practice hot smoking of fish as the only means of preservation. The smokehouses used are traditional structures that consume enormous quantities of mangrove wood.
