Bellagio Marble Ideas Limited, whose registered office is at 6 Heathcote Way, Heathcote Industrial Estate, Warwick CV34 6TE (referred to in this document as "Bellagio Marble Ideas", "Wo" and "Us") warrants that on the day of purchase, and for a period of fifteen (15) years from the date that installation is completed, the Bellagio Marble Ideas worktop ("the Product") shall be free from any defect in materials, subject to the terms and conditions set out in this document.

The warranty shall come into effect on receipt of this signed form, provided that all sums due in respect of supply and installation of the Product have been paid to Us.

This warranty is only applicable to products supplied and installed by or on behalf of Bellagio Marble Ideas in England, Scotland or Wales.

Bellagio Marble Ideas Granite Fifteen Year Material Warranty Warranty Terms & Conditions

A 15 year performance warranty is offered stating that the treated surface will remain water and stain resistant to common non-acidic household liquids when compared to an untreated surface 15 year period. The warranty is offered only when applied by a Dry-Treat Accredited Applicator according to Dry-Treat's application instructions and guidelines, and the surface is maintained regularly using the Recommended Maintenance System (see below). The Warranty does not apply if the product is misused, the surface is not maintained in accordance with the Recommended Maintenance System, the use of surface is inappropriate or the surface is exposed to unusual/excessive environmental conditions.

Recommended maintenance system

Mop up any spills immediately. Regularly clean the surface using HANAFINN Rejuvenata or other non-acidic cleaner suitable for the surface.

Conditions applying to all claims on all Dry-Treat warrantied products:

Surfaces must have been properly maintained according to the

Recommended Maintenance System.

Claims shall be made in writing. Notification must be immediate when possible and made within one month at the latest.

In event of a despite regarding the cause of any damage, the dispute mist be heard by a neutral third party, approved by both parties. The parties shall endeavour to reach agreement on the handling of the claim on the basis of the expert opinion. Costs incurred will be paid by the part held responsible for the damage.

If mutual agreement cannot be reached within six months, either party may commence legal action.

For customers, in the United Kingdom, this warranty shall be governed by and interpreted in accordance with the laws of England and Wales.

Surfaces in saltwater environments deteriorate faster, even if they are sealed, especially softer highly porous materials, including many types of sandstone, limestone, travertine, and some man-made surface materials. For surfaces in saltwater environments, Dry-Treat can only warrant that the surface will remain looking better for longer than an unsealed surface.
