# फडणवीस ‘ड्रग माफिया’ से अनजान कैसे : राउत

नासिक, 20 अक्टूबर (भाषा)।

शिवसेना (उद्धव ठाकरे गुट) के नेता संजय राउत ने मुंबई पुलिस द्वारा 300 करोड़ रुपए मूल्य की ड्रग ‘मेफेड्रोन’ जब्त किए जाने का जिक्र करते हुए शुक्रवार को महाराष्ट्र के उपमुख्यमंत्री देवेंद्र फडणवीस पर राज्य में मादक पदार्थ माफिया को बचाने का आरोप लगाया। महाराष्ट्र में मादक पदार्थ के बढ़ते खतरे के विरोध में नासिक में एक मार्च में शामिल होने से पहले राउत पत्रकारों से बातचीत कर रहे थे।

## प्रधानमंत्री के हाथों करवा दिया आधी-अधूरी परियोजना का लोकार्पण : विपक्ष

देहरादून, 20 अक्टूबर (भाषा)।

प्रधानमंत्री नरेंद्र मोदी द्वारा उत्तराखंड में 132 किलो वाट की पिथौरागढ़—लोहाघाट—चंपावत विद्युत ट्रांसमिशन लाइन के लोकार्पण को लेकर विवाद छिड़ गया है और कांग्रेस सहित विभिन्न विपक्षी दलों ने इस मुद्दे की जांच कराए जाने की मांग की है।

गत 12 अक्टूबर को अपने कुमाऊ दौरे में प्रधानमंत्री ने लगभग 4200 करोड़ रुपए की लागत वाली 23 परियोजनाओं का शिलान्यास और लोकार्पण किया था जिसमें 42 किलोमीटर लंबी इस ट्रांसमिशन लाइन का लोकार्पण भी शामिल था। मुख्य विपक्षी कांग्रेस ने आरोप लगाया कि बिजली सप्लेटेशन न बनने से अभी भी 132 किलो वाट लाइन में केवल 33 किलो वाट बिजली ही चल रही है और राज्य सरकार ने ‘आधी-अधूरी’ परियोजना का प्रधानमंत्री के हाथों उद्घाटन करा दिया।

पार्टी के प्रदेश उपाध्यक्ष सूर्यकांत धसना ने कहा, ‘हम सरकार से मांग करते हैं कि इसकी जांच कराई जाए और इसके लिए जिम्मेदार अधिकारियों को दंडित किया जाए।’ उन्होंने दावा किया कि उक्त सब स्टेशन का निर्माण तो दूर की बात है, अभी तो इसके लिए निविदा प्रक्रिया ही चल रही है।

धसना ने कहा, ‘हमें इस बात को समझना होगा कि जब तक कि यह सब स्टेशन नहीं बन जाता, तब तक इस लाइन में भारी भ्रमका 132 किलो वाट बिजली नहीं गुजारी जा सकती।’
