

CarExpert Exchange Dealer Competition

Terms and Conditions

These terms and conditions apply to the CarExpert Exchange weekly dealer draw. By entering the competition, you agree to and accept these terms.

1. Promoter

The promoter is **CarExpert Ltd** ("CarExpert", "we", "us", "our").

2. Participants

- The competition is open to all licensed automotive dealers actively using CarExpert Exchange to receive and submit quotes.
- "Participant" refers to a dealer (or their nominated staff member) who meets the qualifying criteria.
- Directors, employees, and consultants of CarExpert, or suppliers involved with the competition, are not eligible.

3. Competition period

- The competition runs weekly from Monday 20th October to Sunday 30th November.
- Entries reset each week.

4. How to qualify

- Every valid quote returned in CarExpert Exchange within **4 hours** of being received counts as one entry into that week's draw.
- The more timely quotes you return, the more entries you earn.
- Any breach of these rules will result in disqualification.

5. The draw and prize

- One winner will be selected by electronic draw each **Monday at 10:00am AEST**, conducted by the CarExpert CFO (or delegate).
- The weekly prize is a **\$500 voucher**.
- Prizes cannot be exchanged for cash or any other alternative.
- Winners will be contacted directly and prizes will be delivered **within 7 business days** of confirmation.
- The winner must still be employed at, or contracted to, the original dealer as at the date of prize allocation.

6. Additional terms

- CarExpert may cancel, extend, amend, or suspend the competition by providing reasonable notice.
- CarExpert is not responsible for:
 - a) errors in promotional copy,
 - b) omissions, or
 - c) misrepresentations in materials.
- Participants are responsible for seeking their own tax advice. CarExpert accepts no liability for any tax consequences.
- If fraud or misrepresentation is identified, CarExpert reserves the right to withdraw or cancel the prize.

7. Liability

- By accepting the prize, winners assume all risks associated with its use.
- CarExpert is not liable for any claim, loss, damage, injury, or death resulting from participation in the competition.
