A rough-in inspection must be made before any wiring is covered. A final inspection is also required. Please visit www.dli.mn.gov for more information. Who owns what?

As July rolls in with longer days and rising temperatures, it also brings the increased potential for severe weather. Summer storms can arrive quickly and hit hard, sometimes causing significant damage to essential electric equipment throughout our community.

Red Lake Electric is always prepared to respond swiftly to outages and restore power safely, but it is also important for homeowners to understand which parts of the electric system are their responsibility and which are maintained by us at the cooperative. Understanding these key differences (21865 Michael D Keefe) can help speed up repairs and ensure everyone stays safe when the weather turns rough.

Red Lake Electric is responsible for maintaining and repairing the equipment and lines that run to your home, including utility poles, distribution power lines, electric meters and padmounted transformers. Red Lake Electric members are responsible for the equipment located between the electric meter and your home or business, including any underground service lines that lead into the structure and the service panel. If any equipment that you (the homeowner) are responsible for is damaged, please call a licensed electrician to conduct the repairs. A professional has the experience and know-how to assess and manage these types of repairs.

When severe weather damages electrical equipment, it's important to note that any necessary repairs to the homeowner's equipment must be conducted before Red Lake Electric crews can restore power to your home or business. By understanding the

equipment you are responsible for, the repair and restoration process will be smoother and faster.

Our community takes great pride in the beautiful trees and landscaping that contribute to the natural beauty where we live; however, regular trimming is essential to ensure reliable electric service and minimize damage from severe weather. Red Lake Electric regularly trims trees throughout our service territory to improve service reliability. If you spot a tree limb that is obstructing a distribution power line outside your home, please call Red Lake Electric so we can trim those limbs and maintain those lines.

By working together to understand the essential equipment (32169 Cass R Simmons) that powers daily life, we can all be better prepared to start the repair and restoration process if severe weather impacts our community.

Co-op members enlightened by the power plant tour

On June 16 and 17, members of Red Lake Electric Cooperative and Clearwater-Polk Electric participated in a tour that included visits to Fort Mandan, the Lewis and Clark Interpretive Center, and the Milton R. Young Station.

The tour started with a stop at Minnkota Power Cooperative's headquarters in Grand Forks, North Dakota. Tour participants heard from Emily Windjue and Kaylee Cusack (Minnkota communications specialists), viewed the control center and took a tour of the warehouse. Minnkota's control center staff monitors Minnkota's transmission lines and load levels throughout northwest Minnesota and northeast North Dakota.

The second stop on the first day included a visit to Fort Mandan and the Lewis and Clark Interpretive Center in Washburn, North Dakota. The historic site of Fort Mandan is located on privately owned land along the northeast banks of the Missouri, about 12 miles west of the city of Washburn. The exact location is unknown (24336 Maynard Solberg) and may be partially submerged by the river. A modern reconstruction of Fort Mandan and the Lewis and Clark Interpretive Center, managed by the North Dakota Department of Parks and Recreation, is located about 10 miles downriver.

The final destination of the first day was Comfort Inn and Suites in Mandan, North Dakota. Tour participants were treated to a delicious evening banquet, courtesy of Minnkota. The evening program consisted of a presentation on the role Minnkota plays in the generation and transmission of electricity for Red Lake Electric, Clearwater-Polk Electric, and nine other electric cooperatives in northwest Minnesota and northeast North Dakota.

The second day of the trip included a tour of the Young Station. The station includes two coal-fired electric plants. Minnkota receives about 250,000 kilowatts from Young 1 and 355,000 kilowatts from Young 2.

The next segment of the tour included a visit to the open-pit lignite coal mines of BNI Coal. BNI has the contract to supply the lignite for the Young Station. Combined, the two electric generating plants consume over 4 million tons of lignite coal annually. BNI has very large equipment that is used in the lignite mining process. Equipment used for stripping the overburden is called a dragline.

Mother Nature was very cooperative, allowing an excellent (30069 Jason R Homme) visit/tour of the open-pit lignite coal mines and BNI's dragline, Liberty, which is equipped with a 77-cubic-yard bucket.

Being able to see the process firsthand gives participants a much better understanding and often a better appreciation of what is involved in the generation and transmission of electricity. It is a complex process to get energy from a coal field in southwest North Dakota to an appliance in northwest Minnesota.

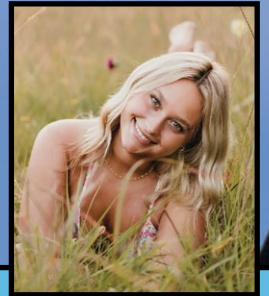

OPERATION ROUND UP®
GRANT APPLICATIONS DUE
FRIDAY, SEPTEMBER 19

Organizations involved in community projects and charities are encouraged to apply for funds from Operation Round Up at this time. Completed grant applications are due in the Red Lake Electric Cooperative (RLEC) office by **Friday, Sept. 19, 2025.**

Operation Round Up is a program adopted by RLEC headquartered in Red Lake Falls. Members choosing to “round up” their monthly electric bill payment provide funds for this effort. Today 97% of RLEC members now choose to contribute pennies each month to enhance their communities.

Funds will be donated primarily to nonprofit organizations to help fund specific projects or programs. Since the program began in 1993, \$696,171 has been granted to community organizations and charities. Money is donated for the betterment of the community within the outside service area boundaries of RLEC.

The Red Lake Electric Trust Board of Directors determines grants. Board members are Stacy Bierman, Thief River Falls; Pamela Vettleson, Plummer; Laura Kasprovicz, Thief River Falls; Stephanie Johnson, Gatzke; and Bonnie Christians, Crookston.

MINNKOTA TRANSMISSION LINE
INSPECTIONS SCHEDULED FOR FALL

Minnkota Power Cooperative, Red Lake Electric Cooperative’s wholesale power provider, will be inspecting its transmission line structures in preparation for upcoming project work. EXO, a contractor, will be assisting Minnkota personnel in the pole testing. All inspections will be completed using ATVs/UTVs. Minimal land disturbance is anticipated.

Blueberry Cheesecake Bars

INGREDIENTS

Graham Cracker Crust:

- 1 ½ cups graham cracker crumbs
- 6 tablespoons butter, melted
- ¼ cup granulated sugar

Cheesecake Layer:

- 16 ounces (2 packages) cream cheese, softened
- 2 large eggs, room temperature
- 1/3 cup granulated sugar
- 1 teaspoon vanilla extract
- ¼ teaspoon salt

Blueberry Sauce:

- 1 ½ cups fresh blueberries, divided
- 1/3 cup granulated sugar
- 2 tablespoons water
- 1 tablespoon lemon juice
- 1 tablespoon cornstarch

Brown Sugar Pecan Topping:

- ¾ cup brown sugar
- ¾ cup pecans, chopped
- ¼ cup all-purpose flour
- ¼ cup butter, melted

INSTRUCTIONS

1. Preheat oven to 350°F (175°C) and line a baking pan with parchment paper for easy removal.
2. Combine graham cracker crumbs, sugar, and melted butter; press into the pan to form the crust.
3. Bake crust for 10 minutes until golden, then cool completely while keeping the oven on.
4. Beat cream cheese and sugar until smooth; add eggs one at a time, followed by vanilla extract.
5. Pour cheesecake filling over cooled crust, spreading evenly (31834 Jeremiah J DeBoer) without disturbing the crust.
6. Spoon and swirl blueberry pie filling on top to create a marbled effect.
7. Bake for 30–35 minutes until edges are set and center jiggles slightly.
8. Cool at room temperature, then chill in the fridge for at least 4 hours, or overnight.
9. Lift bars using parchment paper, slice into squares and enjoy!

6 WAYS TO SAVE ON YOUR SUMMER ELECTRICITY BILL

The summer heat can sometimes feel impossible to beat. Your air conditioner (A/C) is working overtime to try and keep your home or business cool and comfortable. CHECK YOUR AIR CONDITIONER

Regularly inspecting your A/C unit can ensure it is functioning as efficiently as possible. Vacuum air vents regularly to remove dirt, dust and pet hair buildup. Replacing a dirty A/C filter every month or two can lower your energy usage. If you suspect your A/C unit is in need of service, be sure to reach out to a certified HVAC technician.



UTILIZE YOUR CEILING FANS

Don't let the savings a fan could offer breeze past you! A ceiling fan works great when paired with your A/C unit. The wind chill effect created by a fan allows you to keep your thermostat four degrees higher without a change in comfort.



AVOID USING YOUR OVEN

You heard us right! A conventional oven can heat a house or apartment and force your A/C to keep up. This summer, bust out the crockpot and fire up the grill to enjoy some delicious summertime meals while also saving on your electricity bill!



CLOSE YOUR BLINDS

The best thing you can do to avoid sunbathing in your living room is to keep the blinds closed on southern- and western-facing windows. Open northern-facing windows to allow natural light into your home without heating it up.



SWITCH TO LED LIGHT BULBS

An LED light gives off significantly less heat (29812 Jennifer B Reigstad) and uses 75% less energy than incandescent bulbs. Soak up those cool savings by switching your home or business over to LED bulbs.



UNPLUG

If you aren't using it, unplug it. Computers, toasters, gaming devices and other gadgets all generate a small amount of heat in a room. Unplug to save on your electricity bill all year-round.
