

Storage & Handling:

- Store away from direct sunlight
- Store between 36°F and 110°F
- Do not allow to freeze

- Remain active on surfaces, whether wet or dry, often for days, cleaning to the microscopic level as they move across surfaces.
- Provides a stable and healthy microbial community on hard surfaces and fabrics.
- Offers active protection by inhibiting unwanted pathogens repopulating and re-colonizing those surfaces.
- Inhibits pathogen transmission through occupant interactions with surfaces, especially high touch surfaces.
- Safe for use with moisture-tolerant, colorfast materials.

Fast + Effective: Fogging / Misting Enviro Mist is a fast and effective way to repopulate indoor surfaces with safe, beneficial FDA "GRAS" schedule probiotics that provide ongoing cleaning and surface protection between surface cleaning / soil removal protocols. This process also reaches areas that are never "wet wiped" or "wet mopped", and so provides additional unprecedented hygiene and safety.

Active Cleaning: The probiotics in Enviro Mist can move across surfaces, cleaning deep into cracks, crevices, and missed places as they do. This provides a level of active, ongoing surface cleaning conventional cleaners, sanitizers and disinfectants cannot.
