IN 2022, FIRST GENERATION INVESTORS HIRED TWO FULL-TIME STAFF MEMBERS, TRANSITIONING FROM BEING A VOLUNTEER-LED ORGANIZATION TO A STAFF-RUN ORGANIZATION. UNDER STAFF LEADERSHIP, THE PROGRAM HAS STRATEGICALLY SHIFTED FROM ALIGNING WITH COLLEGES TO ALIGNING WITH HIGH SCHOOLS TO IMPACT FURTHER. FIRST GENERATION INVESTORS HAS CREATED FORMAL ALIGNMENTS WITH SEVERAL SCHOOL DISTRICTS AND HIGH SCHOOL-BASED ORGANIZATIONS, INCREASING PROGRAM ACCESS TO THOUSANDS OF STUDENTS.
