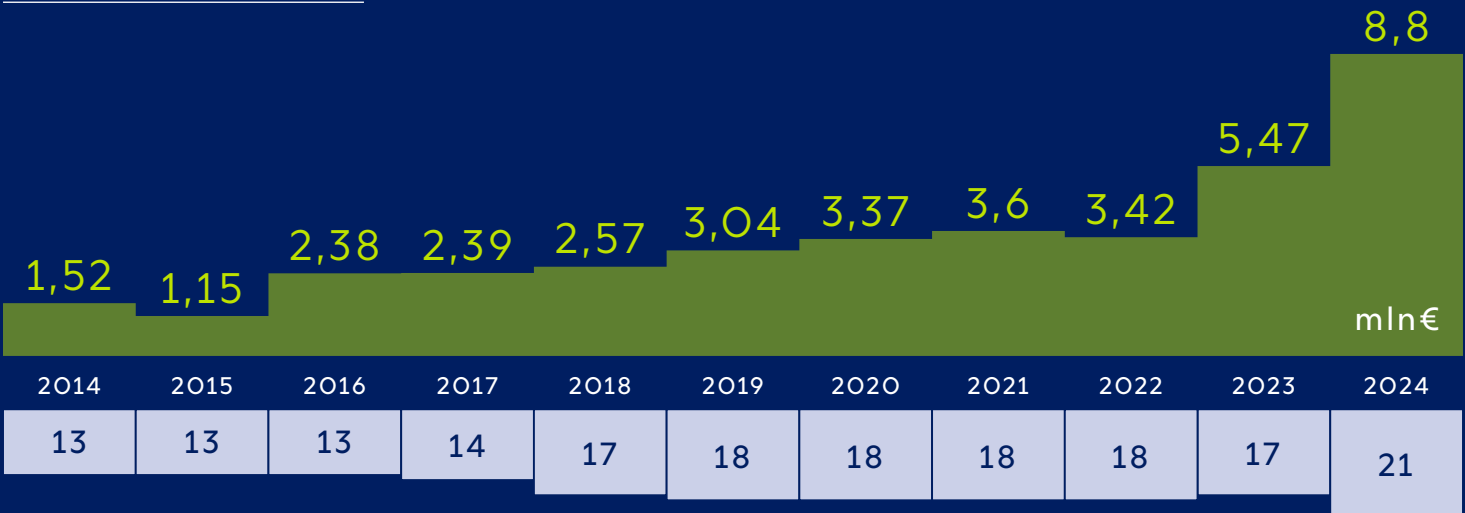


OUR HISTORY

Since our foundation in 2010, we have adopted a structured organizational approach inspired by international corporate models. The introduction of a quality management system, UNI EN ISO 9001 certified since 2015, has enabled us to define strategic objectives focused on client diversification and service offering. For us, the integration of ESG (Environment, Social, Governance) criteria is a driver of growth and innovation. Italia srl (part of RSK Group Limited), managing services in contaminated site characterization and remediation.

We offer specialized expertise to design and supervise effective, safe, and regulation-compliant remediation interventions.

Our approach is based on in-depth analyses, technical modeling, and tailored intervention plans, working alongside a network of experts in environmental engineering, hydrogeology, applied chemistry, and toxicology. This enables us to provide integrated, scientifically robust solutions optimized for environmental risk management.

We support our clients in obtaining the authorizations needed to launch and develop their projects, ensuring full compliance with national, regional, and local regulations, as well as with international reference standards.

We provide assistance at all stages of the permitting process, aiming to simplify procedures, reduce timeframes, and ensure effective dialogue with Competent Authorities. Specifically, we provide support for the granting of Integrated Environmental Authorizations (IEA) and Environmental, Social, and Health Impact Assessments, including the preparation of site environmental baseline studies, where required.

- Environmental, social, and health impact assessments (EIA, SIA, VINCA, HIA)
- Stakeholder engagement and management

Through environmental monitoring services, we support organizations in obtaining and maintaining authorizations, preparing monitoring plans in line with the technical requirements set by current regulations.

We carry out surveys in terrestrial and marine environments, analyzing physical, biological, and landscape matrices. The data collected provides fundamental information for environmental assessments, calibration of predictive models, and spatio-temporal analyses of local phenomena.

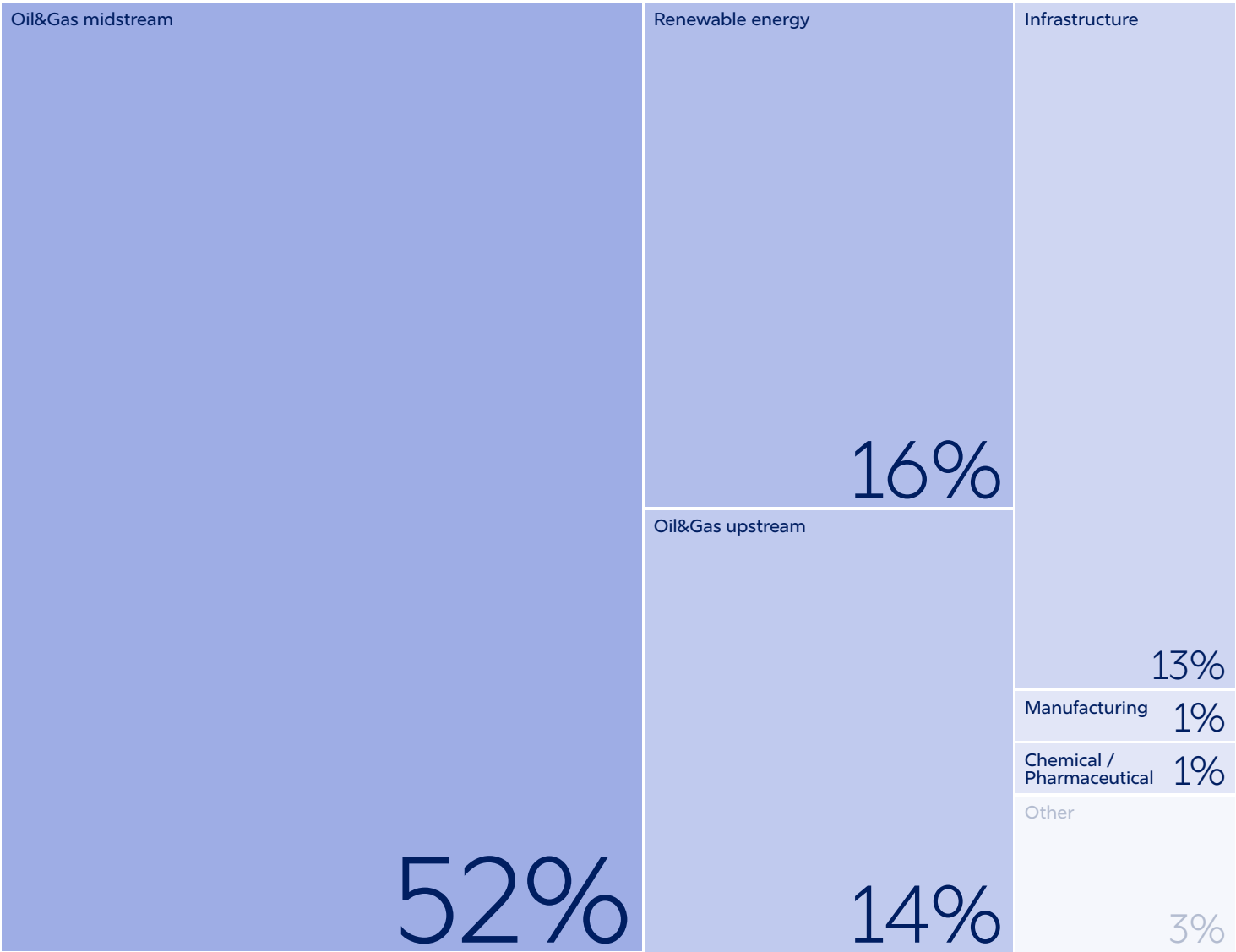
- Investigations on air, soil, subsoil, surface water, groundwater, noise, vibrations, onshore and offshore sediments
- Surveys on fauna, flora, vegetation, ecosystems, and landscape
- Archaeological surveys and waste management studies
- Bathymetric surveys (SBES, MBES) and seabed morphology mapping (side scan sonar, magnetometric surveys, sub-bottom profiler, ROV)
- Topographic surveys and mapping using drones, laser scanners, and multispectral and hyperspectral remote sensing
- Development of geo-databases and data collection and analysis systems (GIS / WebGIS)

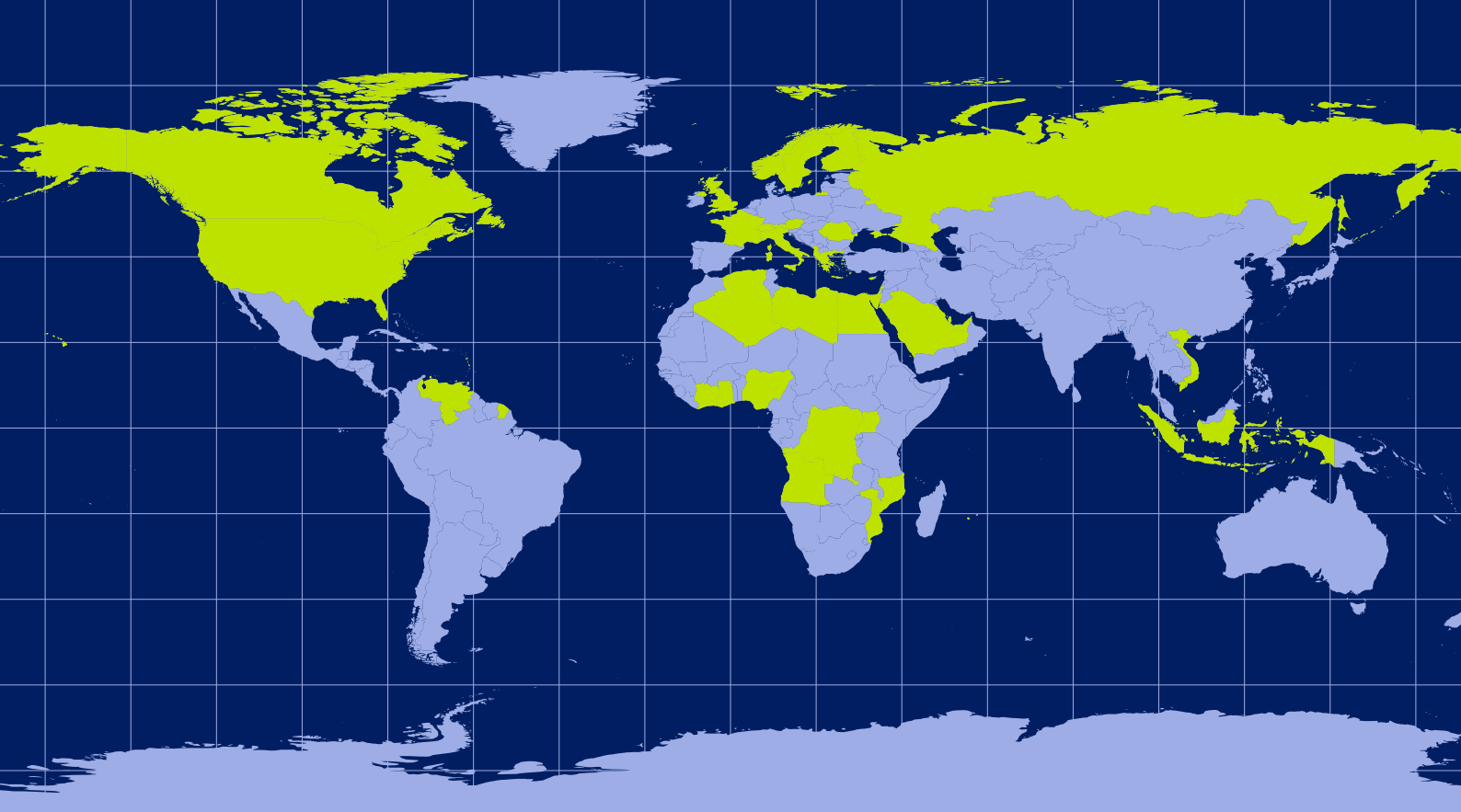
Palla al Centro: building future through education and opportunity
