

Year 2 Planned Projects

In our ongoing effort to provide you with safe and reliable natural gas service, Washington Gas has begun the first five years of a 40-year plan to replace gas main and service lines in various neighborhoods in the District of Columbia. **PROJECT***pipes*, formerly known as the District of Columbia Accelerated Pipe Replacement Plan (APRP), is part of our ongoing pipe replacement work.

Through **PROJECT***pipes*, certain portions of our natural gas infrastructure will be replaced in the coming years on an accelerated basis. For **Year 2** of **PROJECT***pipes*, **October 1, 2015 – September 30, 2016**, the Public Service Commission of the District of Columbia approved the following pipe replacement projects in the District of Columbia:
