

Year 1 Carried Over Planned Projects

In our ongoing effort to provide you with safe and reliable natural gas service, Washington Gas has begun the first five years of a 40-year plan to replace gas main and service lines in various neighborhoods in the District of Columbia. **PROJECT***pipes*, formerly known as the District of Columbia Accelerated Pipe Replacement Plan (APRP), is part of our ongoing pipe replacement work.

Through PROJECTpipes, certain portions of our natural gas infrastructure will be replaced in the coming years on an accelerated basis. For Year 1 of PROJECTpipes, June 1, 2014 – September 30, 2015, the Public Service Commission of the District of Columbia approved the following pipe replacement projects, which have carried over into Year 2:
