Customer Choice gives you the option to buy natural gas from a licensed energy supply company of your choice or from Washington Gas. Since energy supply companies compete in the retail market for your business, these companies may have greater flexibility in how and what they charge. As a regulated utility, Washington Gas charges customers the same price that the company pays for the gas supply.

WHY CONSIDER OTHER COMPANIES?

Two key components make up your natural gas service:

- 1) the **SUPPLY**, or actual natural gas product; and
- 2) the **DISTRIBUTION**, or delivery of the gas.

Your natural gas supply is the part of your service you can purchase from a licensed energy supply company of your choice. Supply charges typically account for the largest part of your bill. Therefore, it may be a good idea to shop around and consider your choices.

Natural gas distribution, or delivery, is the part of your service that remains unaffected if you choose to purchase natural gas from a licensed energy supply company other than Washington Gas.
