

In accordance with Article 13 of EU Regulation 2016/679 of 27 April 2016 (hereinafter: GDPR), we hereby inform you that:

1. The controller within the meaning of Article 4(7) of the GDPR with regard to the personal data of natural persons (Contractor/representatives indicated by the Contractor) responsible for the implementation and performance of the subject matter of the Agreement is Rockfin S.A. with its registered office in Małków, 83-330 Żukowo, ul. Pałacowa 9, registered in Gdańsk Północ, 8th Commercial Division of the National Court Register under KRS number 0001102066, NIP 5850205607, REGON 003005759. 2. The Administrator has appointed Jacek Gołdych (IOD) as the Data Protection Officer. In matters relating to the processing of your personal data or the exercise of your rights, you can contact us by e-mail at: gdpr@rockfin.pl
3. The personal data of the persons referred to in paragraph 1 will be processed by the Controller on the basis of Article 6(1)(f) of the GDPR for the purpose and to the extent necessary to conclude the Agreement, perform tasks or exercise rights related to its performance, as well as on the basis of the premise indicated in Article 6(1)(c) of the GDPR to fulfil the legal obligation specified in the Act on National Archival Resources and Archives, on the basis of which the Controller is obliged to archive documents. c) of the GDPR for the fulfilment of a legal obligation laid down in the Act on National Archival Resources and Archives, on the basis of which the Controller is obliged to archive documents.
4. The data of contact persons, coordinators and persons responsible for the performance of the Agreement have been obtained from the Contractor and will be processed in the category of identification and contact data.
5. The recipients of the data will be authorised employees of the Controller and entities providing services on its behalf, together with their authorised employees who have been entrusted with the processing of personal data on the basis of entrustment agreements. This applies in particular to entities providing legal, advisory, IT and postal services.
6. Personal data will be processed for the duration of the Agreement and then for a period of 3 years after its performance, unless the data subject objects to the processing on grounds relating to his or her particular situation and the Controller does not demonstrate compelling legitimate grounds for further processing or grounds for the establishment, exercise or defence of legal claims. In the event of claims arising from the performance of the Agreement, personal data will be processed until the parties have exhausted all legal remedies.
7. Furthermore, in connection with the Controller's international activities, including branches or subsidiaries located outside the European Economic Area (EEA), personal data may be transferred to third countries. In such cases, the transfer of data is carried out with appropriate safeguards in accordance with the provisions of the GDPR, in particular on the basis of standard contractual clauses adopted by the European Commission or other mechanisms ensuring an adequate level of protection.
8. Data subjects have the right to request the Controller to access their personal data, rectify it, delete it, restrict its processing, object to its processing, and lodge a complaint with the supervisory authority, i.e. the President of the Personal Data Protection Office, if they consider that the processing of personal data violates the provisions of the GDPR.
9. In cases where the conditions specified in the GDPR are not met, the requests cannot be fulfilled.
10. The provision of personal data referred to in paragraph 1 is necessary for the conclusion and performance of this Agreement. Refusal to provide such data will prevent its conclusion or performance.
11. The Contractor undertakes to inform natural persons signing Agreements on behalf of the Counterparty about the content of this information clause, acting on behalf of the Administrator.
