

In accordance with Article 13 of EU Regulation 2016/679 of 27 April 2016 (hereinafter: GDPR), we hereby inform you that:

1. The controller within the meaning of Article 4(7) of EU Regulation 2016/679 of 27 April 2016 (hereinafter: GDPR) with regard to the personal data of LinkedIn portal users is Rockfin S.A. with its registered office in Małków, 83-330 Żukowo, ul. 2. The Administrator has appointed Jacek Gołdych (IOD) as the Data Protection Officer. In matters relating to the processing of your personal data or the exercise of your rights, you can contact us by e-mail at: gdpr@rockfin.pl
3. Personal data will be processed for the purpose of communicating with the Administrator, available at <https://www.linkedin.com/company/rockfinsa/posts/>, in particular in order to respond to reactions, comments and private messages, as well as for statistical purposes.
4. The processing of your personal data is based on the legitimate interest of the Administrator, which is to communicate with LinkedIn users (in accordance with Article 6(1)(f) of the GDPR).
5. Your data will be made available to LinkedIn Ireland Limited and entities authorised to obtain it under the law.
6. Your personal data will be processed until you object or the purposes of processing cease to exist.
7. You have the following rights:
 - a. The right to access your data and receive copies of it,
 - b. The right to rectify (correct) your personal data,
 - c. The right to request the deletion or restriction of processing if further processing is not necessary for Rockfin S.A. to fulfil its legal obligation.
 - d. The right to lodge a complaint with the President of the UODO if you believe that the processing of your personal data violates the provisions of the GDPR.
8. The provision of personal data is subject to the terms and conditions of having an account on Facebook.
9. Furthermore, Rockfin S.A. informs that, together with LinkedIn Ireland, they are joint controllers of personal data within the meaning of Article 26 of the GDPR, in relation to the processing of statistical and advertising data.
10. The scope of LinkedIn Ireland's responsibility for processing your data for the purposes indicated:
 - a. having a legal basis for processing data for website statistics purposes,
 - b. ensuring the rights of data subjects are exercised,
 - c. reporting breaches to the supervisory authority and notifying data subjects affected by the breach about the incident
 - d. ensuring appropriate technical and organisational measures to ensure the security of your data.
11. Scope of Rockfin S.A.'s responsibility for the processing of your data:
 - a. having a legal basis for processing data for statistical purposes,
 - b. fulfilling information obligations regarding the processing purposes pursued by the Controller.
12. LinkedIn Ireland Unlimited Company and ROCKFIN S.A. are joint controllers of personal data in the scope of website statistics (so-called "Page Insights") in accordance with Article 26 of the GDPR. 13. In connection with joint administration with LinkedIn Ireland, the main supervisory authority for data processing is the Irish Data Protection Commission.
