

INFORMATION CLAUSE
(in connection with the use of social media –
Facebook/Messenger)

In accordance with Article 13 of EU Regulation 2016/679 of 27 April 2016 (hereinafter: GDPR), we hereby inform you that:

1. The controller within the meaning of Article 4(7) of EU Regulation 2016/679 of 27 April 2016 (hereinafter: GDPR) with regard to the personal data of Social Media users (Facebook/Messenger) is Rockfin S.A. with its registered office in Małkowo, 83-330 Żukowo, ul. Pałacowa 9, registered in Gdańsk Północ, 8th Commercial Division of the National Court Register under KRS number 0001102066, NIP 5850205607, REGON 003005759. The Administrator can be contacted by e-mail:office@rockfin.pl or by phone +48 58 728 29 00.
2. The Administrator has appointed Jacek Gołdych (IOD) as the Data Protection Officer. In matters If you have any questions regarding the processing of your personal data or the exercise of your rights, you can contact us by e-mail at: gdpr@rockfin.pl
3. Personal data will be processed for purposes related to communication on the Administrator's fan page available at <https://www.facebook.com/firmaRockfin>, in particular to respond to reactions, comments and private messages, as well as for statistical and advertising purposes using tools provided by Facebook.
4. The processing of your personal data is based on the legitimate interest of the Administrator, which is to communicate with users of Social Media, Facebook/Messenger - (in accordance with Article 6(1)(f) of the GDPR).
5. Your data will be made available to Facebook Ireland Limited and entities authorised to obtain it under the law.
6. Your personal data will be processed until you object or the purposes of processing cease to exist.
7. You have:
 - a. The right to access your data and receive a copy of it,
 - b. The right to rectify (correct) your personal data,
 - c. The right to request the deletion or restriction of processing if further processing is not necessary for Rockfin S.A. to comply with a legal obligation.
 - d. The right to lodge a complaint with the President of the Personal Data Protection Office if you believe that the processing of your personal data relating to you violates the provisions of the GDPR.
8. The provision of personal data is subject to the terms and conditions of having an account on the Facebook portal.

9. Furthermore, Rockfin S.A. informs that together with Facebook Ireland Limited (4 Grand Canal Square, Grand Canal Harbour, Dublin 2, Ireland) they are joint controllers of personal data within the meaning of Article 26 of the GDPR, in the scope of processing statistical and advertising data.
10. Joint administration includes the collective analysis of data for the purpose of displaying statistics on Fanpage user activity.
11. The scope of Facebook Ireland's responsibility for processing your data for the purposes indicated:
 - a. having a legal basis for processing data for the purposes of website statistics
 - b. ensuring the rights of data subjects are exercised
 - c. reporting breaches to the supervisory authority and notifying the data subjects concerned about the incident
 - d. providing appropriate technical and organisational measures to ensure the security of your data.
12. Scope of Rockfin S.A.'s responsibility for processing your data:
 - a. having a legal basis for processing data for statistical purposes,
 - b. fulfilling information obligations regarding the purposes of processing carried out by the Controller processing.

13. Facebook Ireland will make the essential content of the appendix concerning website statistics available to data subjects (Article 26(2) of the GDPR) via the data contained in the Website Statistics Information, which can be accessed from all pages.
14. The main supervisory authority for joint data processing is the Irish Data Protection Commission (notwithstanding the provisions of Article 55(2) of the GDPR, where applicable).
