## 1 Introduction

The ethical framework is considered as a guideline for the ECIU University community. The framework provides the basic principles on integrity for everyone participating in the ECIU University community and the ecosystem. ECIU University as an ecosystem, including all its members and stakeholders, act in accordance with the ethical framework.

## 2 Values of ECIU University

The values of ECIU University are as follows:

- Impact on the society
- Resilience into the future

All activities in the ECIU University community reflect the values, including research, education and innovation as well as stakeholder engagement. The values inspire and provide leadership in the realisation of the goals and ambitions of ECIU University ecosystem.

## 3 Roles and responsibilities

The ethical framework is the guiding playbook for all participants in the ECIU University community and the ecosystem. This applies to learners, teachers, researchers, management, and all service providers. Equally, the principles apply to the stakeholders of the ecosystem stemming from outside the academia, both public and private.

In addition, the participants of the ECIU University ecosystem coming from the ECIU member universities are bound to the ethical rules and regulations of the individual ECIU member universities.

- ECIU University drives for honest and reliable actions without private interests.

- ECIU University does not accept offerings that could bias decision-making.
- ECIU University is aware of the direct and indirect social consequences of its activities.
- ECIU University values careful interaction with the nature and living environment in pursuing sustainable development of prosperity and well-being,
- ECIU University respects data confidentiality and consequently treats data with care.
- All members of the ECIU University ecosystem are familiar and comply with legislation, regulations, internal provisions, guidelines and agreements.
