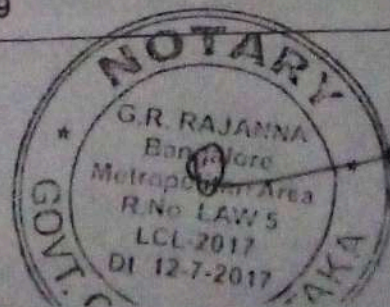

5. Must make appointment of the Teachers as per Ratio of Teachers : Students at 1:40:50.

7. Must recover fee only as per Departmental Rules and must maintain its accounts in the name of the School and must produce during school investigation period.
8. Must obtain prior permission of the Department and open extra Sections/Classes.
9. Must carryout verification of the accounts (auditing) in time to time and file information to this Office.
10. Must get renew Permanent Fund Deposit in time to time.
11. Must follow the syllabus fixed by the Department and teach the same.
12. Shall follow all recognition rules imposed in Karnataka Education Act and Rules, failing which recognition will be withdrawn in pursuant to the rules.
13. Prohibited to give physical punishment and mental torture to the school children.
14. Must give admission compulsorily as per Government Notification Number: ED.27. INFORMATION.2012, dated: 8-05-2012 in Pre-Nursery Classes in

16. Shall ensure that should have complied conditions as per Government Notification Number.ED 240 PGC 2017 Dated: 10/05/2017 and ED 274 PGC 2017 dated 21/10/2017 compulsorily 1st to 10th Standard Kannada Language subject shall be FIRST or SECOND Language.
