## Target Market Determination (TMD)

This Target Market Determination (TMD) is required under section 994B of the Corporations Act 2001 (Cth). It sets out the target market for the product, triggers to review the target market and certain other information. It forms part of the lender's design and distribution framework for the product. A consumer who is a self-managed superannuation fund (SMSF)	Consumer must be a SMSF with a corporate trustee and have a complying SMSF structure.
A consumer who wants a loan for the primary purpose of purchasing residential investment property under a limited recourse borrowing arrangement, or refinancing an existing limited recourse borrowing arrangement where the recourse is limited to a secured residential investment property.	Consumers can borrow up to \$1.5 million with a loan term of up to 30 years in duration.
A consumer who wants a loan that is paid off over time with regular repayments. A consumer who may also want the ability to minimise repayments for a period of time by only repaying interest costs.	The loan requires regular scheduled repayments of principal and interest An interest only term (maximum 5 years) may be agreed with us where scheduled repayments are interest only for a defined period.

- consumers seeking to invest in properties intended for development or construction;
- consumers seeking LVR above 80%; and
- SMSF purchasing or refinancing commercial property.

# Review of this TMD

## Review Triggers

This TMD will be reviewed upon the occurrence of any of the following triggers:

- A material change to the design or distribution of the product, including related documentation or policies;
- Product performance is materially inconsistent with our expectations of the appropriateness of the product to consumers:
  - Where there is a significant change in our total borrowers (joint borrowers to be treated as a single borrower) requiring financial assistance at any one time;
  - Where there is a significant change in our total borrowers (joint borrowers to be treated as a single borrower) that are in arrears;
  - Where there is a significant change in loan applications declined;
  - Where there is a significant or unexpectedly high number of complaints that arise from product or distribution concerns;
- Reporting from distributors, or consistent feedback from distributors on the target market which suggests that the determination may no longer be appropriate;
- Regulator orders or directions in relation to the distribution of this product where we consider this reasonably suggests that this TMD is no longer appropriate;
- The occurrence of a significant dealing in the product outside the target market; and
- A material change to our Credit Policy.
