## BOOKING TERMS

- Deposit may be required to secure booking
- Deposits are non-refundable within 7 days of the event date
- Final guest count due one week prior
- Final confirmed guest count may be used for billing purposes
- Minimum 18% gratuity applies to groups of 15+
- Prices are before tax & gratuity
