CHAIRMAN'S REPORT 2018

"Overcoming poverty is not a gesture of charity. It is the protection of a fundamental human right, the right to dignity and a decent life."

— Nelson Mandela, Former President of South Africa

he father of our nation believed in the eradication of poverty and equality for all. At Ubuntu, our primary objective is poverty alleviation. All the stakeholders, including our donors, members of staff and Board of management, have worked tirelessly in making our vision a reality. For the period under review, the environment posed a huge challenge and our fundraisers overcame this challenge by exceeding their business plan. Without the support of our dedicated donors and members of our staff, both fundraisers and administrative support, it would not have been possible to realise our vision.

Poverty statistics show that our most vulnerable community members are children aged 0 to 17, followed by adults over 55 years of age. KwaZulu-Natal still has areas of extreme poverty, where children live in makeshift mud huts or shacks without parents, and their hunger is very real. Last year, Community Chest allocated R10.1 million to 85 Community Impact Partners who are committed in the alleviation of poverty.

Our aims and objectives would not materialise without the continued kindness and support of our loyal donors, whom I sincerely thank. The contributions received from Charitable Trusts, Corporates and Work Place Giving Donors, Individuals and Bequest donors as well as our Event Sponsors are put to good use to assist those in desperate need. (Detailed lists of our Top Donors can be found inside this report).

The other vital part of the Ubuntu Community Chest machinery is our collaboration with our Community Impact Partners. These registered organisations receive donor resources from us, which are redeployed within needy communities. Social and community workers are employed to work directly with the disadvantaged, thereby improving their lives. I thank them for their effective work that is being undertaken. Collectively, this translates into a safer, healthier and more prosperous community for all our citizens.

In the past year, two special grants were made from the Community Chest Emergency Fund of R50 000 to the



recently opened Ramakrishna Mzamo Children's Home, which caters for severely disabled children, and another R50 000 to the Edith Benson Babies Home, after the disastrous fire that levelled their building to the ground.

Good governance with effective and efficient processes is essential in our management of the Organisation. It is important for me to inform you that we secured the services of PWC as our official auditors after a lengthy procurement process. The Board of Management will also be reviewing the procurement process to ensure that we are aligned with the principles of the King IV report. The extension of our office building project has not commenced, owing to technical difficulties regarding the building plan and the procurement process. A special Board meeting will be scheduled shortly as per our Constitution, to discuss the negative trend of our investment portfolio, which decreased substantially by R2.4 million post year end. We will also host four independent authorised service providers to present proposals to the Board of Management regarding our investment portfolio. The proposals will have to comply with the Financial Services Conduct Authority requirements and the FAIS Act.

Being a volunteer entails being away from one's family and performing one's duties in a fiduciary capacity. I wish to thank the families concerned and the members of the Board for their commitment and dedication.

It is also important that I record our thanks and appreciation to the family of the late Shelagh Hurford for her contribution as a member of the Board of Management.

I wish to express my thanks and appreciation to the management team and members of staff for their commitment and dedication.

in an organisation; she always arrived well-prepared and religiously attended Board meetings. Only serious illness or hospitalisation prevented her from taking her seat at the table.

She was a dedicated, wise and capable person who, despite her illness, meticulously managed our 2018/2019 grant management process, attending her last meeting with us on 27 February this year.

During her career, Shelagh worked for many non-profit organisations in Port Elizabeth, Cape Town and Durban, as well as in the UK. She served on many networks and welfare boards (more than 20 over time). She was instrumental in the establishment of the first non-racial social workers' forum and actively fought for salary parity in terms of social workers' salaries.

More recently, Shelagh was an active member of the Directors' Network, which she chaired for many years, and served on the Provincial Board of Child Welfare, South Africa in various capacities.

She was an avid sports fan who enjoyed remaining up to date on the political developments in South Africa.

Mr McDonald said, "Shelagh was a good person with a good heart and while I am grateful that her suffering has ended, I feel sorry for what we have all lost in her passing".

DIRECTOR'S REPORT 2018

"Extreme poverty anywhere is a threat to human security everywhere."

- Kofi Annan, Seventh Secretary-General of the United Nations

he past year has continued to see even more Non-profit Organisations (NPOs) closing and the communities that they used to serve either doing without vital services or having to travel distances to receive services from another now overburdened organisation. The fact is, the closure of a NPO for any reason is in itself a waste of resources, which we simply cannot afford.

Most NPOs close as a result of ongoing financial deficits, non-compliance with legal requirements and a lack of sound management/good governance. The situation is made worse by an increase in corruption as well as cover-ups on what donor funding is really being spent on.

Understandably, many NPOs use donor funding primarily for their immediate survival without providing for their long-term sustainable planning, including the training of personnel and the improvement of infrastructure.

A successful NPO needs a strong management team with a good strategic plan operating on a more business-like approach. An NPO's financial survival requires trust between the organisation, its donors and the community in which it operates.

During our grant management process, we take a critical look at the applicants who apply for Community Chest funding and identify credible, well managed NPOs. Our stewardship of donor funding is a responsibility that we take very seriously. Our mission can only be achieved if we direct scarce funding to those NPOs that are best placed to use the resources to generate maximum impact over the long term.

Capacity building is a term associated with interventions geared towards strengthening the functioning of NPOs, and we need to make it a priority. With funding obtained from the National Lottery Commission, Community Chest has continued with a training programme to empower and assist its Community Impact Partners with skills that improve operational effectiveness. Capacity building interventions



will become important in the long term – ensuring sustainable impact in communities.

Without resources, we would have no success. We are thankful to have enjoyed wonderful support from our donors. Charitable Trusts contributed generously yet again this year and I acknowledge the trustees who make this possible, including those at Concord Trust, The NBS Centenary Trust, the Fulton Trust, The Victor Daitz Foundation, and the Harry Brunskill Educational and Charitable Trust.

We are grateful for the kind and loyal support of our corporate donors in a tough economy. I especially wish to acknowledge Gelmar (Pty) Ltd, The SPAR Group (Pty) Ltd, Mr Peter Harvey, Dales Bros and Massdiscounters for their continued generosity.

I thank our Workplace Giving donors and the management, shop stewards and payroll administrators of the companies who facilitate this, especially those at GAME/Massdiscounters (Game and Dion), eThekweni Municipality, Standard Bank, First National Bank and SPAR Natal.

Our gratitude also extends to individual donors, sponsors of our events, in-kind donors and partners like the Comrades Marathon that play a vital role in supporting our cause.

Izinhlangano eziningi zivala ngenxa yokusweleka kwezimali, ukungagcini imithetho kanye nokungaphathwa ngendlela efanele. Lesi simo sinezezelwa nawukukhula kwezinga lenkohlakalo kanye nokungaphumeli obala ngokusetshenziswa kwezimali zabaxhasi.

Ngokujwayelekile izinhlangano eziningi zisebenzisa izimali zabaxhasi ukuhlangabezana nezidingo zesikhashana zingahleleli ikusasa lenhlangano, okubandakanya ukuqeqeshwa kwabasebenzi nokulungisa ingqalasizinda.

Inhlangano ephumelelayo idinga ithimba labaphathi abakwaziyo ukubeka imigomo yokuhlelela ikusasa lenhlangano besebenzisa uhlelo olufana nolwamabhizinisi. Ukuphila kahle kwenhlangano kwezezimali kudinga ukwethembana phakathi kwenhlangano, abaxhasi bayo kanye nomphakathi ewusebenzelayo.

Ngenkathi senza uhlelo lwethu lokubhekelela uxhaso lwezinhlangano, siyababhekisisa labo abadinga uxhaso kwiCommunity Chest sibuke ukwethembeka kanye nokuphathwa kahle kwezinhlangano. 





TREASURER'S REPORT 2018

According to Stats SA, the South African economy grew by 1.3% in 2017, exceeding National Treasury's forecast of 1,0%. After a shaky start in 2017, which saw the economy contracting in the first quarter, this improved towards the end of the year. The fourth quarter experienced the highest growth rate of 2017, with the economy expanding by 3,1% quarter-on-quarter (seasonally adjusted and annualised). The estimated growth for 2018 is 1.7%. Our unemployment rate, however, remains at 26.7 %, which equates to almost 15 million unemployed people. We need growth levels multiple times faster than the 1.7% forecast to make any meaningful reduction in the unemployment rate and to have a significant impact on poverty alleviation.



y 31 March 2018, the Community Chest disbursed grants totalling R10.1 million to 85 Community Impact Partners. R293 144 was received and distributed by way of Donor Advised Gifts, bringing total cash disbursed to almost R10.4 million. Donations in kind of approximately R2.2 million were received and redistributed to organisations. Total cash and donations in kind of R12.6 million went to 91 organisations and 17 community-based organisations and schools.

Bearing in mind the continued financial pressure on our Community Impact Partners and our income projections for the 2018/2019 year, the Board decided to increase allocations by 6.9% to R10.8 million, which was allocated to 88 organisations in the coming year.

The Ubuntu Community Chest

Income from charitable trusts, corporates, workplace giving (Give-As-You-Earn) donors, individual donors and special events amounted to R7.4 million, which was an increase of about R600 000 from the previous year.

Included in this was R 715 252 from the NBS Centenary Trust Fund, R79 224 from the Wendy and Roye Palmer Charitable Trust, and R2 633 from the O D Gorven Fund.

We are grateful for the bequests of R1 471 093 that were received during the year.

Expenditure increased by 7.2% over the previous year. Once a fair value adjustment profit on investments of just over R475 018 had been processed, we ended the year with a total comprehensive income of R4.7 million.

The Community Chest Section 18A Fund

The Community Chest Section 18A fund collected R3.6 million, almost identical to the amount collected in the previous

year. Costs of R262 915 were disbursed and distributions of R $_3.37$ million were made, resulting in a surplus of R30 422 for the year.

Donor Advised Gifts

Donor Advised Gifts or donor designated funding of R293 144 was received and redistributed during the year. Smiths Manufacturing donated R90 000 and NCT Forestry gave R100 000. Another R10 200 was received from Scorpion Legal Protection and R9 000 from GIBB (Pty) Ltd.

The National Lotteries Commission donated R900 000 towards our Capacity Building Programme.

Donations in Kind

Goods and sponsorships to the value of R2.2 million were received from Edcon, Woolworths Foods, GAME/Mass Discounters, Keyline Graphics as well as clothing and household goods from members of the community. These were distributed after an assessment was conducted to identify the organisations that needed these items the most.








Midmar Mile - 16 Years and Counting
