## Chairman's Report 2015

The year under review was characterized by some catastrophic events world-wide including the outbreak of the Ebola Virus epidemic in West Africa in which 28 000 people became infected and subsequently more than 11 000 people succumbed to the disease. It was a year in which air travel received much media attention and for all the wrong reasons with the disappearance of the Malaysian Airlines Flight 370, which claimed the lives of the 259 passengers and crew on board.

n the fundraising environment in the past year we saw something new 'The Ice Bucket challenge' phenomenon, a social media fundraising explosion in which more than \$115 million was raised to fund research for the treatment of people infected with ALS (Lou Gehrig's Disease). This proves that if you can get your fundraising formula right, you can raise significant funding.

I want to acknowledge the significant contribution of our previous chairman Ed Booth who has been with the Chest for many years, initially as a representative of the Durban Chamber of Commerce. He left the Board for a while and then returned where he assumed the position of Chairman from 2001 until last year. Under his guidance, the Chest has grown from strength to strength. I thank him for his dedication and hard work and look forward to working with him and enjoying his continued support as he assumes the role of Vice-Chairman.

I am glad to report that Fundraising Income to the Chest, received from our loyal and generous donors increased over the previous year by more than R 400 000 and I thank our donors for their continued support and kindness, as well as for believing in the mission of the Community Chest. During the year we enjoyed generous support from Charitable Trusts/Foundations, Corporates, Work Place donors, Individual donors, Bequest donors, special event donors and sponsorships. (Details of our top donors can be found later in this report).

Donors of In Kind Donations and Donor Advised Gifts contributed almost another R2 million to the Chest allowing us to invest further into our vulnerable communities.

In the 2015/2016year we have decided to increase allocations on average by 5.5%, supporting 83 organisations

with R9.5 million. This increase is based on our income projections for the coming year and the desperate need we see among our organisations.

The Board of Management have continued with our strategic planning process and have engaged the services of external experts to assist us with sharpening our brand which is aimed at making us even more appealing to the wider donor community.

I thank the members of the volunteer Board for their continued involvement with the Chest and for their dedication over the past year. I have enjoyed our meetings and I believe that we are actively working to raise the Community Chest to the next level.

Recently our volunteer Annette Wilkie passed away after a short illness. Annette worked initially at the Community Chest as the bookkeeper and since her retirement in 2001 worked as a weekly volunteer. She was dedicated to the work of Community Chest and she will be sorely missed. We convey our condolences to her family.

Our achievements over the past year would not have happened without the good men and women who work at the Community Chest. I want to acknowledge the commitment and efforts of our staff Gordon Mc Donald our Director, Musa Mbatha our Deputy Director, our Fundraisers and Administrative and support staff. Thank you for your hard work and keep it up. Our communities are relying on us to give them the support that they need, enabling them to do their vital work of improving the lives of our most vulnerable community members.

## **Director's Report 2015**

The core business of the Community Chest is to provide resources to organisations engaged in meeting our community needs. One such initiative is the Community Chest South Africa National Proficiency Index designed collectively by the Community Chests nationally, including the Ubuntu Community Chest.

uring the year, we have continued with the Community Chest National Proficiency Index Programme, whereby funded organisations are assessed regarding their efficiency and effectiveness. The comprehensive assessment is designed to generate a 'gap report' that highlights the training needs of our member societies and we have designed a training programme to address these specific needs.

It was thus extremely fortunate that towards the end of last year we received funding from the National Lottery for our Capacity Building Training Programme and in 2016 we commence the rolling out this training programme. This of course is icing on the cake, and supplementary to our core work of raising funds and resources for our communities.

I am extremely glad to be able to report that yet again this year, we have enjoyed healthy support from our kind donors. While we regularly enjoy donor support, we do not for one second take it for granted and we sincerely appreciate the generosity and loyalty that our donors display towards us. This enables the Community Chest to fulfil its mission of enhancing communities and restoring

The Community Chest operates with a diversified income stream, collecting funds from a range of different donor types, and as the economy goes through its usual ups and downs, our income from the different sectors fluctuates.

## Treasurer's Report 2015

Living in South Africa today is challenging, our economy is not growing at the rate needed to make a significant impact on unemployment. In 2014, our economy grew by only 1.5%, down from 2.2% in 2013. This is according to preliminary estimates of real gross domestic product (GDP) released by Stats SA.

hile unemployment in the fourth quarter of 2014 apparently fell by 11% it remains at about 24.3% (official figures according to Statistics SA). This means 4,9 million people are 'officially' unemployed. This definition consists of jobless people actively looking for work. However, when we include people of working age who have stopped actively looking for work, the figure increases to 34.6%, which equates to 8,1 million people.

Into this mix we can add recurring power outages that we are told we can expect to continue for the next 24-36 months. In a nutshell, we have a struggling economy, unemployment at 34.6% and insufficient electricity to fuel our economy.

Over and above this, our most vulnerable community members are faced with the additional challenges of poverty as they try to improve their lives and those of their children.

During the past year the Community Chest made grants totalling R 8,85 million to 84 organisations another R 472 000 was received and distributed by way of Donor Advised Gifts bringing total cash disbursements to R 9.32 million. Donations in kind of approximately R 1,45 million were received and redistributed to organisations. Thus cash and donations in kind of R10.7 million went to 89 organisations and 22 Community Based Organisations and schools.

Considering our income projections for the 2015/2016 year, and the dire need for funding in the sector, the Allocations Committee agreed to increase grants available by approximately 5.5% to R 9.5 million – this is payable to 83 societies.

#### **The Ubuntu Community Chest**

Income from Charitable Trusts, Business, Workplace Giving (Give-As-You-Earn) donors, individual donors and through special events amounted to R5.8 million, which was an increase of about R 300 000 on the previous year.

Included in this was R492 303 from the NBS Centenary Trust Fund and R41 236 from the Wendy and Roye Palmer Charitable Trust. We in addition received a capital grant of R 200 000 to set up a new perpetual trust in the name of the Gorven Family which will start producing an income stream in the coming year.

Bequests of R235 678 were gratefully received during the year

Expenditure increased by 12.3% over the previous year, largely as a result of unavoidable cost increases. Once a fair value adjustment on investments of R 13,7 million had been processed, we ended the year with total comprehensive income of R15.7 million

#### **The Community Chest Section 18A Fund**

The Community Chest Section 18A fund collected R3,7 million which is an increase of R 100 000 over the previous year. Costs of R266 143 were paid and distributions of R 3 390 349 were made, resulting in a surplus of R54 034 for the year.

#### **Donor Advised Gifts**

Donor Advised Gifts or Donor designated funding of R472 000 was received and redistributed during the year. R270 000 were received from Smiths Manufacturing, R60 000 from SA Container Depot, R39 332 from NCT Forestry, R 10 000 each from Hixonia Nyusulu (Sasol), GIBB and Afripak as well as R24 222 was received from the Robert Storm Trust and another R38 126 was received from the D H Strutt Trust.

#### **Donations in Kind**

Goods to the value of R 1.45 million were received from Edcon, Woolworths Foods and GAME / Massdiscounters, as well as clothing and goods from members of the community which were passed on to organisations who could use them best.







#### A capital bequest

This is normally in the form of a capital donation, usually via a bequest in a will. The sum is preserved and only the income earned on it is used to cover the Community Chest's operating expenses. This ensures that the Community Chest will last in perpetuity. The bequest is usually in the form of cash or equities. Often awards are made (for example, 20% of the residue of the estate).

#### A separate, named fund

A separate fund can be set up within the Community Chest which the donor is free to name (for example, The Roberts Storm Fund). The Community Chest can administer this internally and there are no costs to the fund. The capital is preserved and only the income is distributed annually. The donor can specify who the fund beneficiaries should be (for example, the elderly or children). The distribution of funds is separate from the Community Chest's other allocations and the recipients are made aware that the



donation is from a specific fund. This is a rewarding way to ensure that the efforts of a philanthropic person are remembered and appreciated by future generations.

#### A general fund

Donations are used for distribution in the current year and go towards the millions the Community Chest needs to raise annually in order to meet its funding obligations to beneficiaries. The donor can specify if the donation should go into the general fund or if it should be used in a specific way (for example, for children's homes, care for the disabled, etc.)

By leaving an enduring legacy to the Community Chest, you can make a meaningful and sustainable contribution to the welfare of our most vulnerable citizens.
