If your pet is NOT traveling with you they must travel within 5 days of your departure otherwise an Export Health Certificate will be required rather than an Animal Health Certificate.

Tapeworm treatment is required when traveling with dogs (not cats or ferrets) from Great Britain to EU listed tapeworm free countries including **Northern Ireland, Malta, Ireland, and Finland**. These dogs must be treated for tapeworm by a veterinary surgeon not more than 120 hours (5 days) and not less than 24 hours before the time of entry into one of these countries. Please select one of the following options to confirm whether your dog will need tapeworm treatment:

NB - before returning to Great Britain dogs must be treated for tapeworm not less than 24 hours, not more than 120 hours (5 days) before time of entry except for return from Northern Ireland, Finland, Ireland, or Malta. This must be done by an EU vet who must also certify this in the relevant section of the AHC.

If you are leaving Great Britain on a short trip returning within 120 hours (5 days) you must have this treatment done by a veterinary surgeon before leaving.
