President Garst then moved to Item No. 1: REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING MINUTES: Supervisor Trapp made the motion to approve the Previous Board Meeting Minutes for April 05, 2016 after modifications to be made on item 3. The motion was seconded by Secretary Hicks and unanimously carried.
