Item No. 1: REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING MINUTES: After review of the previous board meeting minutes, Supervisor Garst made the motion accept and approve the board meeting minutes for November 12, 2019 with a change on the last paragraph. -Water Dept.: the control issues at the water tower have been resolved, the IP address was the issue but it has been corrected by VTX1 and Circle R.

Ferris & Flinn came by to inspect the old water storage tank and they will be doing an estimate for a rehab to get the storage tank repaired and have as a possible third tank.

The district received a letter stating the previous tanks were condemned after the last inspection and that is the reason for building the new storage tanks.

Item No. 5: GENERAL MANAGERS REPORT: Ron Mills, General Manager, addressed the board on the following:

- Aging Report: 9 meters were pulled and 4 have been reinstalled.
- Storage Tank Update: the storage tanks have been completed.
- Appointment Update: advised the board that it is time to complete an application for reappointments or any new applicants interested.
