-Replacement of Water line at 5 mile Bridge: will be completed after San Perlita replacement.

-CCR Notice to and from TCEQ: we received a letter stating that our CCR Notice was not posted on our website, which we do have it posted since July 2019. We also need to include in our CCR Notice any violations that NAWSC has.

-Public Notice for Sewer Plant Permit Renewal: we have advertised on the Raymondville Chronicle and submitted proof of public notice.
