Chairman Rains called the meeting to order at 9:03 a.m.. Upon conclusion of roll call, it was ascertained that a quorum was present.

Item No. 1: REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING MINUTES: Upon review of the September 14, 2016 Meeting Minutes, Commissioner Hulen made a motion to approve the previous board meeting minutes with modifications to item numbers 7 and 8. Secretary Hicks seconded the motion and upon a vote and the motion unanimously carried.

Item No. 3: PRESENTATION ON REPRESENTATION SERVICES FROM RON WHITLOCK: Ron Whitlock, Director of Shepard Group, presented the board a proposal for Public Policy Advocacy for the Port of Port Mansfield.
