Chairman Rains called the meeting to order at 9:00 a.m.; upon conclusion of roll call, it was ascertained that a quorum was present. Chairman Rains called for affidavits of conflict of interest and there were none.

Item No. 1: REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING MINUTES: Upon review of the September 12, 2018, previous board meeting minutes, Commissioner Brown made a motion that the board meeting minutes be re-written and presented at the next board meeting for approval. The motion was seconded by Secretary Hicks and unanimously carried.

Item No. 3: REVIEW AND ACTION ON SUBMISSION OF BID PROPOSAL FOR PAVING PROJECTS: After review and discussion on the submission of bid proposal for paving projects, Secretary Hicks made the motion for Ferris & Flynn to advertise and to proceed the bidding process.
