Chairman Rains called the meeting to order at 9:00 a.m., upon conclusion of roll call, it was ascertained that a quorum was present.

Item No. 1: REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING MINUTES: Upon review of the December 13, 2017 Meeting Minutes, Commissioner Hulen made a motion to approve the previous board meeting minutes with corrections on No. 5, Police Chief Monthly Report. The motion was seconded by Secretary Hicks and upon a vote the motion unanimously carried.

Item No. 2: *PUBLIC COMMENT:*

Item No. 3: PORT POLICE CHIEF MONTHLY SUMMARY: Chief Mayes, was not present, he was out sick. Port Director Ron Mills, stated there was a couple of issues of animals not on leashes and we are trying to work on it.

Item No. 4: PORT DIRECTORS REPORT: Port Director Ron Mills, reported on the following items:

-Structure Engineering Update: contacted the dredging company, will go with Ron Whitlock next week to seek dredging money. People have had issues outside of the jetties that is not going to be taken care of in the first phase.

Item No. 5: REVIEW AND DISCUSSION OF BUILDING PERMITS ISSUED FOR THE MONTH OF DECEMBER 2017: The board reviewed and discussed the building permits that were issued for the month of December 2017.
