Item No. 1: REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING MINUTES: Upon review of the May 13, 2020, board meeting minutes, Commissioner Kinney made the motion to approve the previous board meeting minutes as presented. The motion was seconded by Secretary Reyes and the vote unanimously carried.

Item No. 2: PUBLIC COMMENT:

Alma Castaneda: Canceled lease Block A, Lot 21/Maria del Carmen Cantu de Garcia – Lease had been canceled due to default and would like the lease to be returned to Maria del Carmen de Garcia due to not being able to pay her lease based on being ill. Ms. Castaneda also was upset because the neighbor on the north side cut the pier to the property.

Item No. 3: REVIEW AND DECISION ON SHEPARDS GROUP CONTRACT:
