Chad Kinney, Chairman called the meeting to order at 9:00 a.m.; upon conclusion of roll call, it was ascertained that a quorum was present. Kinney called for affidavits of conflict of interest, and there were none.

Item No. 1: REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING MINUTES: Upon review of the January 11, 2023 board meeting minutes, Commissioner Kendrick made the motion to approve the previous board meeting minutes as presented. The motion was seconded by Commissioner Trevino and the vote unanimously carried.

Item No. 3: DISCUSSION AND ACTION ON 2022 AUDIT REPORT: Quinton Anderson, Carr Riggs & Ingram CPA's and Advisors, presented the results of the audit report for the 2021 – 2022 financial statements of the Willacy County Navigation District. Quinton, summarized information of the audit report to the board. The motion was made by Commissioner Trevino to approve the audit report for 2021 – 2022 as presented. The motion was seconded by Commissioner Kendrick and the vote unanimously

Item No. 4: DISCUSSION AND ACTION ON NOMINATIONS AND/OR REINSTATEMENT TO PMPUD BOARD OF SUPERVISORS. After board discussion of 2 vacancies for PMPUD of Supervisors, there are 2 applicants. Commissioner Kendrick made the motion to accept Dean Charles and David Alanis as Supervisors of the PMPUD Board. The motion was seconded by Commissioner Trevino and the vote unanimously carried.

Item No. 5: PORT POLICE CHIEF MONTHLY SUMMARY REGARDING LAW ENFORCEMENT OPERATIONS, INVESTIGATIONS, CRIME REPORTS AND STATISTICS, ARRESTS, CRIMINAL OR SUSPICIOUS ACTIVITY, MIGRANT ACTIVITY, LAND AND WASTER RESCUES, PUBLIC SAFETY RELATED INFORMATION, PERSONNEL MATTERS AND EQUIPMENT OR TECHNOLOGY MATTERS: Chief Mayes reported the following: busy month, issued warrants, migrant problem continues, gate crashing, dumping calls, no thefts reported and call volumes are the same.

Item No. 6: PORT DIRECTORS' REPORT: Port Director Ron Mills reported on the following:

- 2023 Legislative Tour: a total of 83 legislators showed Friday before last presentation to VTX. Potential things are coming.
- Leases for New Subdivision: on the 9th of February the lots were leased. Bids from Ferris & Flinn for sewer and water so lessee cannot construct until July, 2023.
Lots 16 to 47 need water and sewer.

Item No.7: REVIEW AND DISCUSSION OF BUILDING AUTHORIZATIONS ISSUED FOR THE MONTH OF JANUARY, 2023: The building authorizations issued for the month of January, 2023 were reviewed or discussed.

Secretary Reyes made the motion to accept and approve the leases as presented. The motion was seconded by Commissioner Kendrick and the vote unanimously carried.
