Chad Kinney, Chairman called the meeting to order at 9:03 a.m.; upon conclusion of roll call, it was ascertained that a quorum was present. Kinney called for affidavits of conflict of interest, and there was none.

Item No. 1: <u>REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING</u> <u>MINUTES</u>: Upon review of the September 11, 2024 board meeting minutes, Commissioner Trevino made the motion to approve the previous board meeting minutes. The motion was seconded by Secretary Reyes and vote unanimously carried.

Item No. 2: PUBLIC COMMENT(S):

John King: addressed the board that he is a legal scout of class of 1966, Pastor of the church. Mr. King requested a copy of his lease, as he was not aware that leaseholders were not owners of the land for which his home was built.

Miller Bassler: To Mr. Trevino, pursuant to the social media post this week to allow him a 3 minute window of time. Port Mansfield concerned citizens are not against commerce, they are in common sense support commerce. They are not for the dirty destructive commerce that will bring barges and containers to Port Mansfield. Mr. Bassler stated that Residential property value in Port Mansfield will drop and will worsen the tax base of the community. Mr. Bassler also stated that NAS appears to be a scam.

Kathy Bassler: addressed the board she will continue Mr. Basslers' statement. Mrs. Bassler stated they as concerned citizens are fighting for new common sense leadership and a strategic plan, not dirty business.
