Alberto Trevion, Pro-Chairman called the meeting to order at 9:07 a.m.; upon conclusion of roll call, it was ascertained that a quorum was present. Trevino called for affidavits of conflict of interest, and there was none.

Item No. 1: <u>REVIEW & CONSIDERATION OF PREVIOUS BOARD MEETING</u> <u>MINUTES</u>: Upon review of the October 09, 2024 board meeting minutes, Commissioner Kendrick made the motion to approve the previous board meeting minutes. The motion was seconded by Secretary Reyes and vote unanimously carried.

Item No. 2: PUBLIC COMMENT(S):

Jason Graham: began with a burst of profanity and angrily complained about loud music and foul language from Blue's Bar & Grill, then he explained he was trying to offer a sample or what he hears at Blue's Bar & Grill located near his home. Mr. Graham accused the Willacy County Navigation District for ignoring his complaints about the loud music and profanity because the bar is owned by former Chairman Chad Kinney. On September 28 he complained to Port Mansfield Police Chief Mayes claiming the loud music and he was cited for disorderly conduct.

John King: requesting a copy of land ownership for Port Mansfield, would like to find out who owns the dirt since it is not stated on the lease.

Miller Bassler: spoke about the most recent WCND election results, said that the people of Willacy County Navigation District have spoken and delivered a clear and decisive mandate that this board was headed in the wrong direction with plans to turn Port

Mansfield into a shipping container. Mr. Bassler addressed the board that numerous fabrications and lies had been posted on social media by board member Stacy Reyes, whom attempted to slander and defame the character of local businessman to discredit the campaign in contest of Mr. Brown against Mr. Cavazos.

Marsha Visser: addressed the board that she is looking forward to Mr. Kennedys leadership and has work for the next election coming up. Ms. Visser thanked Mr. Brown and Mr. Kennedy for delivering the message out to the public that the container project is a bad idea.

Bernice Burton: addressed the board that she has seen people on social media representing NAS videos.

Mark Sanchez: from Edinburg, Texas, his past history started with NAS, purpose to provide solutions and rights. Sanchez, stated that Briseno operates out of Tampico and provided strategic plans. They specialize on environmental studies and would like to bring positive opportunities and about 200 jobs into this city.

Eric Kennedy will take office as Chairman at-large.

Precinct 1, Commissioner:

Ernesto Cavazos – 606, Mark Brown – 572.

Ernesto Cavazos will continue his position as Commissioner for Precinct 1.

The motion was seconded by Secretary Reyes and vote unanimously carried.

- Item No. 6: <u>DISCUSSION AND POSSIBLE ACTION INSTRUCTING THE EXECUTIVE PORT DIRECTOR TO ENTER INTO A CONTRACT WITH A THIRD PARTY INDEPENDENT AUDITOR TO REVIEW ALL LEASE RATES FOR ALL LEASE HOLD PROPERTY</u>: After discussion, Commissioner Trevino made the motion to instruct Executive Port Director Mills to enter into a contract with a third party auditor to review all lease rates for all lease hold property. The motion was seconded by Commissioner Cavazos and vote unanimously carried.
