Item No. 1: <u>CONSIDERATION AND POSSIBLE ACTION REGARDING THE EMPLOYMENT AND DUTIES OF A NEW EXECUTIVE PORT DIRECTOR:</u> After discussion regarding the employment and duties of a new Executive Port Director, the Port Director will be a long-term position, full strategic responsibilities, including annual budget development, infrastructure planning, regulatory compliance and intergovernmental relations. The board refined job descriptions to clarify that that the director negotiates but does not approve contracts. The final sign-off remains with commissioners.

Item No. 2: DISCUSSION AND POSSIBLE ACTION REGARDING GENERAL WCND OPERATIONS, ADMINISTRATION, AND MANAGEMENT MATTERS RELATING TO BUDGETING AND FINANCES: PROCUREMENT AND CONTRACTS: MAINTENANCE AND IMPROVEMNTS TO DISTRICT FACILITIES AND INFRASTRUCTURE; PORT **OPERATIONS** AND SECURITY: REGULATORY COMPLIANCE: COMMUNICATIONS; INTERGOVERNMENTAL RELATIONS; AND PLANNING AND <u>DEVELOPMENT ACTIVITIES</u>: After discussion, Commissioner Trevino made the motion to appoint Virginia Lomas as Interim Manager in replacement of the Director and authorize to start contacting agencies to help find a business manager/port director. Attorney Allison will initiate agency contacts and refine postings. Permits will follow the same procedures. However, for new construction they will be forwarded to Frank Vasquez, Port Superintendent to review the plans. The motion was seconded by Commissioner Cavazos and vote carried.
