<b>Common Hazards</b>	<b>Safe Job Practices</b>
<ul style="list-style-type: none"> <li><b>Slips, Trips, and Falls</b></li> <li><b>Lack of stability</b></li> </ul>	<ul style="list-style-type: none"> <li>Use of a personal fall protection system is mandated when working where employees are exposed to falls greater than 6 feet. JLG shall be utilized when working on the crane where tie-off is unavailable or feasible, especially when setting counterweights and baskets.</li> <li>Keep ladders, walking surfaces, stairs, and stepping surfaces free of objects and obstacles.</li> <li>Only step on ladders, stairs, walking, and stepping surfaces with sufficiently clear height.</li> <li>Only step on ladders, stairs, walking, and stepping surfaces with clean shoes.</li> <li>Keep ladders, stairs, walking, and stepping surfaces free of heavy dirt, snow, ice, and mud.</li> <li>Stepping on ladders, stairs, walking surfaces, and stepping surfaces by persons, including tools and equipment, weighing more than 330lbs, is prohibited.</li> <li>Do <b>not</b> step on damaged ladders, stairs, walking surfaces, and stepping surfaces, and replace them immediately.</li> <li>Do <b>not</b> trip over attachment parts.</li> <li>Personnel must wear an approved fall arrest system and protective equipment before performing any work on the crane structure</li> <li>Personnel must hook themselves to the hook points and safety ropes with an approved fall arrest system to prevent falling.</li> </ul>


Common Hazards	Safe Job Practices
<ul style="list-style-type: none"> <li>• <b>Crushing Injury Hazard</b></li> </ul>	<ul style="list-style-type: none"> <li>• Barricade all accessible areas to the crane so personnel cannot be struck or crushed when upper works are swung.</li> <li>• Do not climb on or off the crane while the upper works are swung or the crane is being traveled.</li> <li>• Signal operator that you need to climb on or off the crane.</li> <li>• Operator: do not swing or travel while personnel climbs on or off the crane. Stop swing and travel motions. Apply the swing brake and turn on the Travel Brake.</li> <li>• Use of dedicated spotters and signal persons when flying objects with cranes.</li> <li>• Use of tag lines when a rotating load may become a hazard.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>Struck By/ Caught Between/Pinch Point Hazards</b></li> </ul>	<ul style="list-style-type: none"> <li>• Hard Hats and Safety Glasses shall be worn at all times during the assembly/disassembly of this crane.</li> <li>• Never handle wire rope with bare hands. Always wear heavy-duty gloves to prevent being cut by broken wires.</li> <li>• Use extreme care when handling coiled pendants. The stored energy can cause coiled pendants to uncoil quickly with considerable force.</li> <li>• Do not attempt to maintain or repair any part of the crane while the engine is running unless necessary.</li> <li>• If the engine must be run, keep your clothing and all parts of your body away from moving parts. <b><i>Maintain constant verbal communication between the person in control and the person performing maintenance or repair procedures.</i></b></li> <li>• Do not use your hands to check for air and hydraulic oil leaks</li> <li>• Relieve pressure before disconnecting air, coolant, and hydraulic lines and fittings.</li> <li>• Do not attempt to lift heavy components by hand. Use a hoist, jacks, or blocking to raise components.</li> <li>• Store tools, oil cans, spare parts, and other necessary equipment in toolboxes. Do not allow these items to lie loose in the operator's cab or on walkways and stairs.</li> <li>• Use of dedicated spotters to direct and signal all vehicle traffic.</li> </ul>

Common Hazards	Safe Job Practices	
<ul style="list-style-type: none"><li>• <b>Collapsing Boom Hazard</b></li></ul>	<ul style="list-style-type: none"><li>• Select a suitable location for boom disassembly. It must be firm, level, and free of obstructions.</li><li>• It should have enough open space to accommodate the crane, the boom length, and - if required - the movement of an assist crane or other equipment.</li><li>• If possible, secure the area to keep unauthorized personnel and vehicles away.</li><li>• Do not remove the bottom connecting pins from any boom section when straps support the boom</li><li>• Do not remove bottom connecting pins from any boom section when the boom point is resting on the ground and handling pendants are slack</li><li>• Do not remove strap connecting pins until straps are fully lowered into supports</li></ul> <p>Never work or stand inside the boom unless it is lowered and securely blocked, as shown.</p>

Common Hazards	Safe Job Practices
<ul style="list-style-type: none"> <li>• <b>Designate Assembly Area</b></li> </ul>	<ul style="list-style-type: none"> <li>• Select a good location to assemble the crane</li> <li>• Ensure ground conditions are firm, level and uniformly supportive in compliance with engineer's soil data.</li> <li>• Select an area large enough and free of any underground or overhead obstructions or hazards to accommodate the crane, assist the crane, select boom and jib length, and the movement of trailers.</li> <li>• Erection area should not interfere with or pose a hazard to other onsite personnel. Erection area to be marked and barricaded.</li> <li>• There should be at least 2 feet of clearance between the counterweights and the nearest obstacle.</li> <li>• Ensure there is enough timber blocking to support the boom when it is being assembled.</li> <li>• Ground support, as specified in the erection drawings, is complete and in compliance with the stated requirements.</li> <li>• When lifting, lowering, and swinging crane parts in and out, no persons may remain in the danger zone.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>Assist Crane Overload</b></li> </ul>	<p>Site restrictions and manufacturer specifications shall size the assist crane.            Site conditions and matting must be suitable for maximum loading of the assist crane.            The assist crane will assembled by the manufacturer's instructions.</p>
<ul style="list-style-type: none"> <li>• <b>Rigging Failure</b></li> </ul>	<p>Rigging shall be inspected per applicable OSHA/ASME standards, at least daily and before use. Examples of unserviceable rigging include bird caging, kinks, and broken wires.</p>
<ul style="list-style-type: none"> <li>• <b>Electrical Shock Hazard</b></li> </ul>	<p>Ensure adequate clearance from power lines is maintained per ASME B30.5 and the manufacturer's recommendations in the Operation's manual.</p>

***Note: At no time will a trainee, apprentice, or an oiler operate any crane during the assembly, reconfiguration, and disassembly process or while the crane is in bypass.***
