Bengaluru: Students, principal among nine arrested for skit defaming Dalits

EXPRESS NEWS SERVICE BENGALURU, FEBRUARY 13

A TOTAL of nine persons — seven students, principal Dinesh Nilkant and programme organiser, Centre for Management Studies, Jain University — were arrested on Monday for a skit that allegedly defamed Dr B R Ambedkar and Dalits, DCP South Krishnakanth G said on Monday. He said further investigation into the matter is on.

The accused have been arrested under section 3(1)(f) (intentionally insults or intimidates with intent to humiliate a member of SC or ST in any place within public view), 3(1)(s) (abuses any member of ST or SC by caste name in any place in any place within public view) and 3(1)(v) (by words either written or spoken or by any other means disrespects

any late person held in high esteem by members of SC or ST) of SC and ST (Prevention of Atrocities) Act and IPC 1860 under section 153A (Promoting enmity), 149 (unlawful assembly) and 295A (Deliberate and malicious acts, intended to outrage religious feelings of any class by insulting its religion or religious beliefs), upon a complaint registered by Madhusudhana KN, assistant director, grade 1 of Social Welfare Department, Bengaluru South.

The Karnataka State Commission for Scheduled Castes and Scheduled Tribes has written to Jain University seeking a detailed report on the incident.

The Bengaluru University Postgraduate and Research Students' Union has also called for a self-imposed bandh on Tuesday against Jain University for allowing a "derogatory play" defaming an eminent leader.

The controversial skit was performed Wednesday at NIMHANS Convention Center during a youth festival organised by CMS.

In an alleged video that went viral, some students are seen performing 'Mad Ads' focusing on the reservation policy. The skit involved dialogues that were allegedly "offensive towards Dr Ambedkar and the Dalit community", and enraged pro-Dalit groups in Karnataka and Maharashtra.

The authorities at CMS, meanwhile, maintained that the video that has been circulated is "half-baked" and the full clip actually shows the overall picture of reservation and caste system. "The skit was not presented before faculties. The students performed extempore on the stage. We have already issued a public apology," said a college official.

Uttarakhand: Man killed in Turkey quake cremated

THE BODY of 36-year-old Vijay Kumar, who died in last week's devastating earthquake in Turkey, was flown to Delhi on Monday morning and cremated in Kotdwar, Uttarakhand.

Kumar's body was handed over to his family members in Delhi, who then brought it to Muktidham here for the last rites, Devendra Nawani, a relative, told PTI.

A resident of Padampur area of Kotdwar in Pauri district, Vijay Kumar worked for a Bengaluru-based company and was in Turkey on an official assignment.

He went missing after the massive earthquake hit Turkey and Syria on February 6, killing

more than 30,000 people. Vijay Kumar's body was found on Saturday as workers cleared the debris of a hotel in the Turkish city of Malatya, where he was staying. Quoting Indian embassy officials, the family had earlier said that Vijay Kumar was identified by an "Om" tattoo on his hand. His face was crushed beyond recognition. He is survived by his wife and a six-year-old son.

Case against Setalvad, 2 former IPS officers sent to sessions court for trial

A METROPOLITAN magistrate's court here on Monday committed the case to the sessions court for trial a case against social activist Teesta Setalvad and two former IPS officers wherein they are accused of fabricating evidence to frame "innocent people and defame Gujarat" in connection with the 2002 post-Godhra riots in the state.

Additional metropolitan magistrate MV Chauhan committed the case to the sessions court in Ahmedabad for trial against Setalvad, former state Director General of Police RB Sreekumar and ex-Indian Police Service (IPS) officer Sanjiv Bhatt. The Ahmedabad city police's crime branch had registered an FIR (first information report) against them in June 2022, and a special investigation team (SIT) formed to probe the case had filed a chargesheet in the metropolitan magistrate's court on September 21 last year.

While Mumbai-based activist Setalvad and Sreekumar, arrested in June 2022, are currently out on interim bail, Bhatt is serving a life sentence in a jail in Palanpur in Gujarat's Banaskantha district in a custodial death matter.

According to existing legal norms, all cases relating to offences punishable with a life sentence or jail term exceeding seven years are to be committed to a sessions court for trial.

The crime branch had registered the FIR against the trio after the Supreme Court last year dismissed a petition challenging the clean chit given by an earlier SIT to then-Gujarat Chief Minister Narendra Modi and others in cases related to post-Godhra communal riots.

The Gujarat riots were triggered by the torching of a coach

of Sabarmati Express by a mob near Godhra station on February 27, 2002. Fifty-nine passengers, mostly Hindu Karsevaks returning from Ayodhya, were charred to death in the incident.

All three have been accused of abusing the process of law by conspiring to fabricate evidence with an attempt to frame "innocent people" for an offence punishable with capital punishment in connection with the 2002 riots. In its 6,300-page chargesheet, the SIT formed to investigate the case against the trio has cited 90 witnesses, including retired IPS officer-turned-lawyer Rahul Sharma and Congress Rajya Sabha MP Shaktisinh Gohil.

A K Malhotra, a member of the earlier SIT appointed by the Supreme Court to look into the riots cases and the officer who had questioned Modi, is also among the witnesses.

Among the documentary evidence in the chargesheet is a copy of a complaint filed by Zakia Jafri, widow of former Congress MP Ehsan Jafri, in June 2006 in which she had accused 63 persons, including then-CM Modi, of "wilful dereliction" of duty.

Ehsan Jafri was among the

68 people killed at Ahmedabad's Gulberg Housing Society during violence on February 28, 2002, a day after the Godhra train burning.

Zakia Jafri's protest petition in the Gujarat High Court, her statement as a witness, copies of nine affidavits filed by Sreekumar before the SC-appointed SIT, copies of fax and emails sent by Bhatt are also among documentary evidence produced by the SIT.

The FIR against them was registered a day after the apex court dismissed the plea of Zakia Jafri and observed, "At the end of the day, it appears to us that a coalesced effort of the disgruntled officials of the State of Gujarat along with others was to create sensation by making revelations which were false to their own knowledge." Setalvad, Sreekumar and Bhatt were booked under sections of the Indian Penal Code related to forgery, fabricating false evidence with intent to procure conviction of capital offence, instituting criminal proceedings to cause injury, framing incorrect record or writing with intent to save person from punishment or property from forfeiture, and criminal conspiracy.

Apologise for remarks on Morbi tiles: Industry body to social media influencer

AN INDUSTRY body on Monday demanded an apology from a social media influencer for allegedly denigrating tiles manufactured in Morbi, Gujarat.

Mukesh Kundariya, president of vitrified tiles division of Morbi Ceramic Association (MCA), invited the social media influencer, Vivek Bindra, to visit Morbi to know about the quality of tiles manufactured here.

"Vivek Bindra said in a video that Morbi tiles are of poor quality. We would like to tell him that Morbi tiles are being exported to 180 countries...If Bindraji has no knowledge of Morbi tiles, he should visit Morbi and see the process of its manufacturing and understand its quality," Kundariya told reporters.

Bindra posted a video on Facebook in which he described "tiles made in Morbi" to be that of poor quality compared to "shining Italian tiles".

According to Kundariya, the association has demanded an apology from Bindra and also removal of the video. He also threatened to take legal action, if the demands are not met.

Vinod Bhadja, president of floor tiles division of Morbi Ceramic Association, said that Morbi ceramics are in direct competition with tiles manufactured in China and European countries including Italy.

"Bindraji should first study the topic before posting on social media for cheap publicity as it damages our reputation," he said.

Gujarat BJP appoints four new district chiefs

GUJARAT BJP president CR Paatil has appointed new district unit presidents for Banaskantha, Devbhumi Dwarka, Amreli, and Surendranagar districts, a party release said on Monday.

While the post of the district chief was vacant in Amreli and Surendranagar, district committees in the rest two districts were dissolved by Paatil after incumbent presidents had expressed their desire to step down, it said.

Former Minister of State for Education, Kirtisinh Vaghela, will be the new district unit chief for

Banaskantha. He lost to Congress' Amrutji Thakor from Kankrej seat in the December 2022 state Assembly polls.

Three other new appointees include Mayurdan Gadhvi, Rajesh Kabaria, and Hitendrasinh Chauhan for Devbhumi Dwarka, Amreli, and Surendranagar districts, respectively.
