Terms and Conditions

A. Introduction

This **Business Fibre Basic Promo** ("Campaign") is made available by CelcomDigi, subject to the terms and conditions provided herein.

You acknowledge that you have read and fully understood these terms and conditions and hereby agree to be bound by these terms and conditions which shall be read together with the General Terms and Conditions for Enterprise Service ("GTC"), the Specific Terms and Conditions for CelcomDigi Business Fibre ("STC"), and the respective terms and conditions for the selected products and/or services, and CelcomDigi's (i) Privacy Notice: Fair Usage Policy, as published CelcomDigi Website and (ii) at https://business.celcomdigi.com/terms-conditions, all of which form an integral part of full terms and conditions of the products and/or services (collectively referred to as the "Terms and Conditions").

In the event of a conflict or inconsistency between the terms and conditions of this Campaign and the terms and conditions of the GTC, STC and the respective mobile/content service(s), such inconsistency shall be resolved according to the following order of priority:

- i) first the terms of this Campaign;
- ii) second the Registration Form;
- iii) third the terms of the STC;
- iv) fourth the terms of the respective mobile/content service(s), where applicable; and
- v) fifth the terms of the GTC.

Unless the context otherwise requires, the capitalised terms hereunder have the meanings assigned to them in the GTC and STC for CelcomDigi Business Fibre.

B. Duration of Campaign

This Campaign shall commence from **16**th **June 2025** until **further notice** ("**Campaign Period**"). Any extension or discontinuation thereof shall be at the sole discretion of CelcomDigi.

C. Eligibility

- 2. CelcomDigi's decisions in any matter in relation to these Terms and Conditions shall be final and conclusive. Any request for appeal or review shall not be entertained.
- 3. CelcomDigi shall not be liable for any claim by the Customer or third-party claims or losses of any nature, including but not limited to, loss of profits, punitive, indirect, special, incidental, or consequential damages or for other damages and any related claims of any nature, including direct, indirect, third party, consequential or other damages resulting from or in connection with these Terms and Conditions.
- 4. CelcomDigi reserve the right to reject or terminate any subscription to the Service hereunder if the Customer is in breach of any of its obligations or any of these Terms and Conditions. Notwithstanding the foregoing, CelcomDigi reserve the right to reject or terminate the said subscription at its sole and absolute discretion without having to assign any reasons whatsoever.
- 5. The processing of the Customer's personal data will be in accordance with CelcomDigi's Privacy Notice. Additional personal data processing will be covered in **Section F** below, if applicable.
- 6. CelcomDigi do not take any responsibility in the event the Customer is prevented from subscribing to the Service (including any additional service under the Terms and Conditions) as a result of certain technical restrictions, other limitations or force majeure which include but not limited to regulatory and/or Government directive, act of God etc.
- 6. In the event any of these Terms and Conditions is invalid, illegal and unenforceable under any applicable law or for any reason whatsoever, the legality and enforceability of the remaining provisions shall not be affected. No delay or indulgence by CelcomDigi in enforcing any terms or conditions herein shall constitute a waiver by CelcomDigi of the Customer's breach of these Terms and Conditions.



7. These Terms and Conditions shall be construed and governed by the laws of Malaysia. In the event of a dispute, the courts of Malaysia shall have exclusive jurisdiction.

F. Processing of Personal Data

- 1. CelcomDigi only collects personal data that is necessary for this Campaign such as your name, phone number and email address.
- 2. CelcomDigi only processes the Customer's personal data for purposes of processing and assessing the Customer's eligibility and participation herein.
- 3. All personal data provided is stored on CelcomDigi's secured servers as long as necessary for the processing.
- 4. The Customer's personal data may be shared with CelcomDigi's partners and service providers to help CelcomDigi run this Campaign. CelcomDigi may also have legal obligations to provide the Customer's Personal Data to the authorities.
- 5. The Customer has the right to:
 - i. withdraw the Customer's participation in this Campaign;
 - ii. access and correct the Customer's personal data; and
 - iii. request CelcomDigi to stop processing the Customer's personal data.
