

Duties of the Governor of Texas

The voters of Texas have a unique opportunity every four years to elect into office a person who will essentially be responsible for the lives of millions of citizens in the eighth-largest economy in the world. Many people believe that the Governor of Texas is just a “fluff” role in government, but that could not be further from the truth.

What Can A Texas Governor Do?

Among other core duties, the Texas Governor is the Commander-in-Chief of the state’s military forces, which includes the Texas Army National Guard, Texas Air National Guard, and Texas State Guard. Additionally, the governor is responsible for policy recommendations for both the state House and state Senate and has the power to veto or sign into law any bill which is passed by the Legislature.

Similar to the President of the United States, the Texas Governor can grant commutations and reprieves as recommended by the Board of Pardons and Paroles. One of the most important responsibilities is appointing the Secretary of State and others who oversee state departments and agencies, which impact the lives of every Texan.

Who Is The Texas Governor?

Governor Greg Abbott was born in Wichita Falls, Texas, and raised in Duncanville, a city in southwestern Dallas County. Shortly after graduating from Vanderbilt University with a law degree, he was paralyzed by a falling tree while jogging.

Greg never let his disability slow him down, though! He likes to say: “Life is defined not by the challenges we face, but by how we respond to those challenges.”

Governor Greg Abbott served as a District Court Judge in Harris County and then as a Justice on the Texas

Supreme Court from 1996-2001. Abbott was the Texas Attorney General from 2002-2015 before being elected as Governor in 2014, making him the longest-serving incumbent Governor in the United States.

Greg is married to Cecilia Abbott, the first Hispanic First Lady of Texas. They have one daughter, Audrey, who recently married her college sweetheart. Governor Abbott and Cecilia live in Austin with their three Golden Retrievers: Peaches, Pancake, and Honey Butter Chicken Biscuit.

What Has Abbott Done For Texas?

Over the past eleven years, Governor Greg Abbott has helped shape Texas into the fastest-growing economy in the United States. He is proud to have passed the largest school-choice program in the nation during the last Legislative Session, allowing thousands of Texas families the means to choose the best educational path possible for their children.

Under Governor Abbott’s leadership and guidance, the Texas Legislature provided the largest property tax cut in Texas history in 2023, which will help millions upon millions of hard-working individuals and families across the state.

Governor Greg Abbott also recognizes the need to keep Texas families safe, promoting bills which protect our border and defend our state from federal overreach. 

How Does The Texas Attorney General Impact Our Lives?

Kent Paxton, the current Attorney General of Texas, is vacating his position to run for US Senate. This leaves open one of the most powerful leadership roles in the state. *Several have thrown their hat in the ring for AG and you can read more about one in this LINK Letter.*

The Attorney General is the top lawyer for the state of Texas and has many responsibilities, including serving as legal counsel for all boards and agencies of state government. In fact, the Texas Constitution contains nearly 2,000 references to the Texas Attorney General.

Additionally, the Texas AG leads more than 4,000 employees in 38 divisions and 117 offices throughout the state, including nearly 750 attorneys who handle more than 30,000 cases annually.

Duties And Responsibilities

The Texas AG defends the laws and Constitution of the state and represents the state – and even individual state employees – in court when needed.

The Texas AG issues legal opinions when requested by the Governor and other officials/agencies and files civil suits upon referral by other state agencies.

The Texas AG cannot represent private citizens or offer legal advice to offspring, but he/she does serve and protect the rights of all Texans, ensuring their health and safety through various government agencies.

The Texas AG is also responsible for the collection of court-ordered child support and the administration of the Crime Victims' Compensation Fund.

NOTE: Under Ken Paxton's leadership, the Texas Child Support Division collected more than \$4.8 billion dollars in fiscal year 2020 – an unprecedented amount in one year by any state.

Initiatives Of The AG'S Office

In addition to defending the state in legal battles in the courtroom, there are several initiatives which the Texas AG is responsible for.

Human Trafficking: The Texas AG's office assists law enforcement and prosecutors on human trafficking cases, assists victims with resources, and presides over the Texas Human Trafficking Prevention Task Force and Coordinating Council.

A broken food system harms our families, weakens our workforce, and drives farmers and ranchers off the land. The Power of the Agriculture Commissioner

A Broken Food System

A broken food system produces broken health outcomes. Taxpayers pay the price! America spends \$4 trillion annually, with three out of four dollars tied to preventable chronic disease. Texas Medicaid spending exploded 300% in twenty years.

Meanwhile, Texas farmers are being pushed to the edge. America lost 142,000 farms between 2017–2022. During that time, Texas lost 17,754 farms and is on course to lose an average of 68 farms per week. Since 1997, Texas lost 3.7 million acres of working lands—much of it snapped up by

foreign buyers, including adversarial nations like China. That's a national security threat not fixed by this year's law prohibiting future land purchases by hostile nations.

Threats to our Agriculture System

Our agriculture system is threatened at the border by invasive pests and agroterrorism. During the recent screwworm scare, the Trump Administration's response required cooperation. Instead of working with our partners, Sid Miller chose publicity stunts and finger-pointing—blaming the Trump Administration for his own failures.

And this fits a pattern. Miller voted for in-state tuition for illegal immigrants (HB1403 - 2001). In 2017, in meetings with Mexican officials, Miller said Mexico should "have input" on Trump's border wall. His positions acted as magnets for illegal entry and helped roadblock citizen-first solutions.
