Thank you to all of our rugby league communities, staff, zones, districts, clubs and volunteers who prioritised the health and safety of their people above all else. Thank you to those who re-shaped seasons, ran new-look and often fragmented competitions and managed isolation and vaccination requirements in the face of Omicron.

Your resilience saw our game survive significantly trying times, and while not entirely out of the woods yet, we embrace 2022, full steam ahead.

Despite Omicron cancelling the 2021 NZRL Secondary Schools, we still ran the NZRL Youth and National competitions, albeit in a revised format, without Auckland teams, due to Covid restrictions at the time. Congratulations to Upper Central and Canterbury for taking home the Men's and Women's National Championships and Upper Central and Mid Central for being crowned 2021 16s and 18s Youth Champions.

Our withdrawal from the 2021 Rugby League World Cup, although disappointing, was the correct decision due to health and safety concerns surrounding the pandemic in the Northern Hemisphere.

Although challenging for all involved, the competition's postponement to this year means all teams can now experience the entire spectacle, at its best, with full-strength teams, player engagement, and stadiums full of fans enjoying the biggest RLWC in its history.

Despite pandemic setbacks, there were still many reasons to celebrate in 2021.

The Ngā Ringa Āwhina team engaged with league clubs and districts across Aotearoa ensuring delivery of better capability building across the game.

We are pleased to have deepened our partnership with NZ Māori Rugby League and will be implementing constitutional changes that further enhance this relationship.

Despite the Omicron challenges, we are encouraged by a positive increase in rugby league participation. This is a testament to the loyalty and dedication shown by our grassroots communities throughout challenging periods. Our rangatahi participation has increased by 15%, relatively quicker than other codes, and our female participation continues to gain momentum each year, increasing by 13%.

For the first time in over ten years, direct grassroots funding has more than doubled due to our continuing efforts to stabilise the balance sheet.

We are incredibly grateful to our principal partners, Pirtek and Mainstream, who have renewed their commitment despite the 2021 high-performance hiatus. We have also sealed a direct long-term partnership agreement with Sky, meaning more domestic and international exposure at all levels.

We continue to build relationships with NRL, Sport NZ and High-Performance Sport NZ, whose increased funding enables us to further invest in the development of rugby league across New Zealand.

Despite a nervous start to 2022, the year's momentum is now in full swing.

The Sky Sport Women's Premiership and National 20s competition returned for successful second seasons. Congratulations to the Akarana Women, who broke an 11-year drought, upsetting reigning champions Counties Manukau to secure the Sky Sport trophy for 2022. The Akarana 20s also took home the Ruben Wiki Cup after an impressive performance against the South Island in the National 20s final at Auckland's Mt Smart.

NZRL ran its inaugural District 9s competition over Easter weekend. Hundreds flocked to Auckland's Bruce Pulman Park to see the districts battle it out for the inaugural championships. Thank you to Sky Sport for televising each match and providing widespread awareness for our community game across the country. Congratulations to Canterbury for taking out the Boy's 16s and 18s divisions and to Mangere East and Wellington for taking out the 16s and 18s Girl's competitions.

While many challenges remain and the pandemic pressures still linger, we look forward, with great confidence, to an uninterrupted 2022 rugby league season which is shaping up to be the busiest NZRL has seen to date.

We are excited to finally see the return of the NZRL Secondary Schools competition, Youth Competition and NZ16s and 18s representative calendars, and we welcome with great enthusiasm the return of our Kiwis and Kiwi Ferns to Aotearoa.

Matariki weekend saw us face Pacific rivals Mate Ma'a Tonga in a blockbuster double-header that marked the return of international Test match rugby league and the return of one of the biggest rivalries in our game. We made history, breaking a world record for a women's rugby league Test crowd attendance, and both our Kiwis and Kiwi Ferns came away with impressive victories.

The June Double-Header celebrated our first stop on the World Cup Waka as we set sail for the UK in October. We look forward to seeing the Black & White shine on the RLWC stage.

We will continue to work to build an international calendar post RLWC that will see a greater presence of content in the New Zealand market each year.

NZRL would not have navigated its way through yet another year of Covid setbacks if it were not for our consortium of valued partners. Thank you to Sport NZ, High-Performance Sport NZ, the Ministry of Education and ACC, and our principal sponsor partners such as Pirtek, Mainstream, BLK, Sky Sport, and our valuable support partners.

Thank you to our other partner associate members, NZ Māori Rugby League, Physical Disability Rugby League, New Zealand Universities & Tertiary Students Rugby League, Masters Rugby League, NZ Police, NZ Defence Forces and The Kiwis Association.

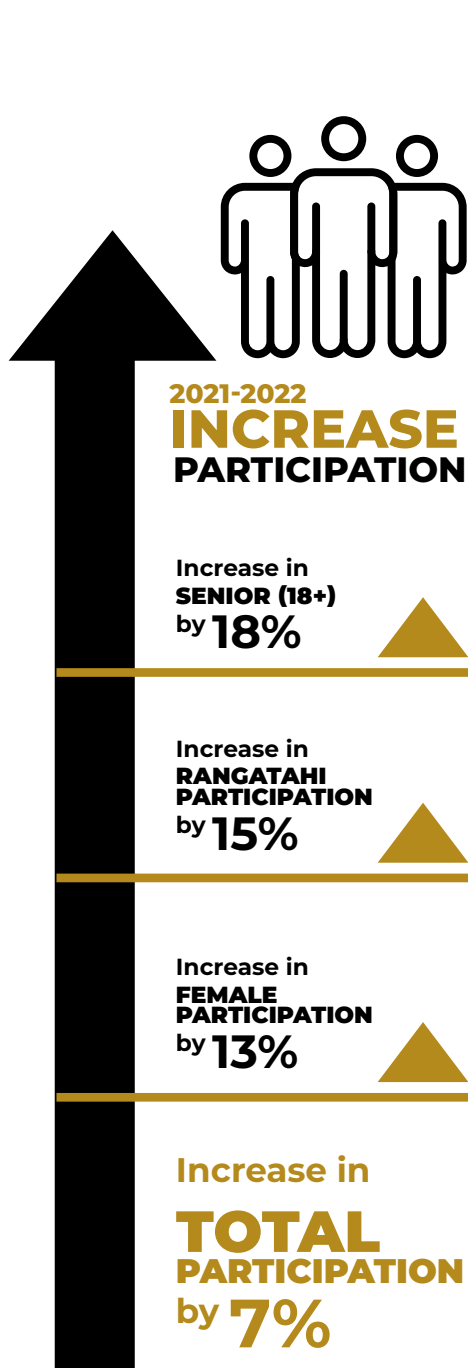

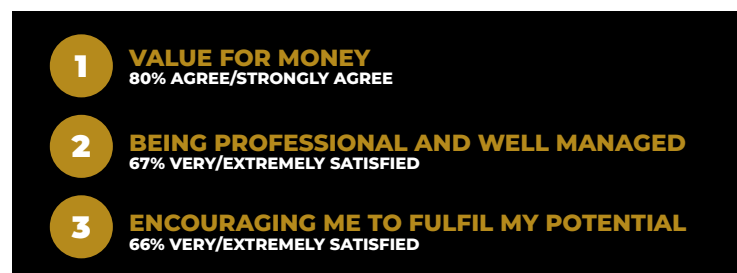
Women and rangatahi participation has now surpassed 2019 pre-covid numbers

Women's Rugby League

Whutupōro Riki Wāhine

Aspiring Her Game Developers

Aspiring Her Game Developers (AHGD) network group continues to lead the way in their rugby league communities.

The following are some of the wins the AHGD have made throughout the year:

- The formation of Wellington Rugby League's women's advisory group aimed at increasing development opportunities for women and girls.
- With a priority to increase female leadership off the field, two former Wellington Orcas and Kiwi Ferns members completed their Senior Club Coach accreditation in Wellington to assist with their coaching pathways.
- The first female Head Coach for Wellington Orcas women's team was appointed, who is also one of the Aspiring Her leads in the region.
- An Aspiring Her game development leader from the Upper-Central zone took a lead role in starting two inaugural women's teams at her local club in Te Awamutu. The women's teams competed in a local Midlands competition involving twelve other women's teams.

Revised National Women's Competition

Delivering a National Women's competition against strict Covid restrictions in the Auckland and Northland regions was a huge development boost for teams, volunteers and communities involved.

With Covid alert levels and strict isolation protocols in place, NZRL could not run the Sky Sport Women's Premiership and National Championship in its proper form, involving upper North Island teams.

Despite this, it was encouraging to have a modified National competition delivered with the participation of Upper Central Zone, Canterbury, Wellington, and Mid-Central Vipers. The competition ran over four weeks and was televised live on Sky Sport. Teams travelled across the region for the round-robin games and concluded with the grand final played at Nga Puna Wai Stadium in Canterbury. The Canterbury women's team were

victorious on the day, beating the Wellington Orcas to take out the 2021 National Competition.

Wellington and Upper Central Zone, who would typically be part of the National Championship, were able to experience a week-to-week competition and the demands of Premiership-level rugby league.

2022

The Sky Sport Women's Premiership returned for 2022, with both Auckland teams participating after missing out on the opportunity last year due to Covid. Congratulations to Akarana for breaking Counties' 11-year winning streak to take home the 2022 title.

The 2022 Premiership ran around the same time as the NRLW, which meant 11 Premiership athletes were unable to participate; however, this provided opportunities for new athletes to make their zone representative teams and contest for a place in the Kiwi Ferns June Test squad.

The Sky Sport Women's Premiership continues to provide a high-level representative competition for New Zealand's best regional players. Congratulations to 2022 Sky Sport Women's Premiership MVP Laishon Albert-Jones, who earned her maiden Kiwi Ferns call-up off the back of an outstanding performance for Akarana.

NZRL also ran its inaugural District 9s competition involving Girls and Boys 16s and 18s age group divisions.

The new District 9s Tournament brought back the rivalry and competition at a regional level and fostered young female rangatahi talent throughout the country. Congratulations to Mangere East for taking out the Girls 16s age group and Wellington for taking out Girls 18s competition. The District 9s was an exciting addition to the women's football calendar, and NZRL look forward to it continuing and improving year on year.

2022 will continue to be action-packed in the women's space. NZRL look forward to implementing the inaugural Secondary Schools Girl's Tournament and inaugural National Youth 16s and 18s Tournaments towards the end of the year – milestones for the female game.







Coaching

Whakangungu

Although 2021 presented several Covid-related challenges for NZRL's coaching community, the coaching and development staff were able to call on their adaptability and expert knowledge to provide some relief throughout trying times.

Online Learning

The NZRL online coach education platform (Sport Tutor) provided further coach development for coaches hindered by the recent Covid restrictions. With over 12 new online modules covering position-specific, player wellbeing and coach planning topics, it has proven beneficial to our community coaches' growth mindset and continual development. Over 845 people are now registered to the portal.

2021 also saw the first Kiwi League Senior Club Coach online course with 15 male and two female coaches in attendance. Each session had multiple points of engagement from break-out room discussions, video, PowerPoint and interactive polls to ensure the coaches were challenged on many levels.

The use of the world-renowned game and player analysis software Hudl was introduced to the National 20s and National Women's coaching staff. The free use of this software made available by NZRL helped raise the performance level of both competitions.

High Performance Sport NZ

NZRL has substantially increased the number of coaches involved in the high-performance coaching pathway development. Eight (six male and two female) NZRL coaches were invited into the HPSNZ Te Hāpaitanga and Core Knowledge programmes. These programmes provide the next step for our coaches on their pathway to excellence by developing the expert coaching skill required to help the NZ Resident representative player transition to the next level in the player pathway.

WNA (Warriors, NZRL and ARL) Coach Development Programme

Seventeen identified coaches were involved in a new coach development initiative with the NZ Warriors and Auckland Rugby League, aimed at coaches of the rangatahi (youth) age group. The sessions were facilitated by NZRL and ARL staff and Kiwi legends Stacey Jones, Tony Iro, and Jerry Seuseu and covered player wellbeing, session planning, coaching philosophies and designing drills for specific skill sets.

NZ Resident 18s

2021 saw the inclusion of the first NZ 18s female side into the NZ resident campaigns. Coaching staff with international coaching and playing experience have been appointed. The players on this team will be well prepared for the representative duties and the subsequent phases of their player pathway.

There have also been several coach development extension sessions held across the country by the zones supported by the National Game Development Officers. With a focus on building the community coach's capabilities to plan, develop self-directed players and create positive environments for the players to grow. These sessions will significantly increase our game's participation levels to ensure the clubs are thriving hubs in the community.

Ngā Ringa Āwhina

Strengthen and adapt

Ngā Ringa Āwhina, our capability-building programme focusing on cultural awareness, wellbeing, game development and governance and administration, commenced in August.

Funded by Sport NZ through their Strengthen and Adapt programme as part of the Government's Covid-19 Sport Recovery Package, the Ngā Ringa Āwhina team aim to provide support nationally and is guided by the rugby league community. The Ngā Ringa Āwhina team consists of a workforce that reflects the rugby league community to increase connectedness whanaungatanga and ensure we reach the desired objectives and outcomes.



Key highlights:

- 22 of 28 Auckland clubs have implemented Xero accounting software, improving the overall financial management of organisations for increased efficiency and transparency.
 - “Xero has been lifechanging for us. I can be match managing and create an invoice at the same time, all from my phone. It has really simplified things” – Vic from Marist RL.
 - Creation of Club Smart website. An online library of resources and templates to support all functions of running a club.
 - Online workshops provided for upskilling in match management, competition administration, grant funding and governance training.
 - Wananga held in districts delivering wellbeing workshops, coaching and trainers courses and governance and administration training.
 - “The activation day held in the West Coast was just what the Coast needed. Being upskilled on all aspects of the game and getting the wellbeing side of things included is perfect with players and coaching getting involved and helping our clubs with capability” Michael Cook – West Coast.
 - The Ngā Ringa Āwhina team look forward to working with the rugby league community this year and beyond with a focus on quality improvement practices to ensure that we continue to meet the needs of the community.

Community - Playgroups

Hapori

Playgroups are an extension of NZRL's service to the rugby league community, providing a quality early learning service for children and families who may not have the opportunity to access it otherwise.

For many, participating and engaging in Playgroups is the first step of any formal education. Playgroups are an asset to those most vulnerable in our community, providing tamariki with learning opportunities they may not ordinarily have access to.

Playgroups have been developed further to align with the vision of NZRL's strategic plan.

The programme encompasses the four key principles of 'The Kiwi Way' and addresses the expectations of the Ministry of Education outcomes, which we have identified as:

1. "To lift aspirations and raise educational achievement for every New Zealander" and
2. "For every child to learn and thrive in high-quality settings that support their identity, language and culture and that parents and whanau value them."
3. Ka Hikitia
4. Te Whāriki

To achieve these outcomes, NZRL continues to increase the quality of our delivery and ensure that our identified communities, Māori, Pasifika, and all tamariki will have the opportunity to experience a quality learning environment where they feel welcomed, respected, and safe. Where tamariki can connect and strengthen their relationships, feel valued by parents/whānau, and support their cultural identity and wellbeing, we hope each child will thrive and excel in these core principles.

As the Covid-19 pandemic continues, Playgroups have adapted to service and offer support to whānau through digitally-based programming and activities. NZRL offered Online Playgroups with physical playgroup learning packs to support our online learning curriculum. This program was delivered weekly and saw large engagement.

Playgroups visited Motat and Auckland Zoo as lockdown restrictions were lifted. This was an opportunity for the Playgroups whānau to visit for the first time as parents have expressed difficulty in meeting financial requirements to enjoy these venues without the support of Playgroups.

We saw enrolment numbers double since last year. There are many factors, from online exposure over lockdown to parents working from home and new parents who potentially lost employment and seek a free alternative learning environment.







Wellbeing

Hauora

Covid-19 presented its fair share of challenges in 2021; however, the wellbeing team were able to pivot to maximise other opportunities.

During the lockdown periods, the team offered wellbeing support and advice through social media by interviewing former Kiwi and Kiwi Fern players to talk openly and reflect on lessons from their careers. The Real Talk live streams had over 20,000 views. Ali Lauitiiti and Jerry Seuseu were able to host guests such as former Kiwi and Kiwi Fern players Henry Faafili, Jerome Ropati, Joe Vagana, Georgia Hale, Sam Rapiro, Sione Faumuina, David Solomona and Joe Galuvao.

SPORTS CHAPLAINCY NZ

We continued our relationship with Sports Chaplaincy through key contact Cliff Thompson, who was able to assign chaplains to many of our representative teams. In addition, we saw the involvement of Janet Tuitama in some of our workshop deliveries to the women's teams.

NZRL WELLBEING WAKA PROJECT

In partnership with Le Va, NZRL revisited the Wellbeing Waka campaign to improve rugby league communities' mental health and wellbeing outcomes across New Zealand while building sustainable wellbeing capability within zones and districts.

Another 30 people agreed to come on as "Wellbeing Champions" across the motu, including the notable addition of past NRL players such as Sam Rapiro, Herewini Te Rangi, Sione Faumuina, Ben Henry, David Bhana, Russell Packer, Henry Faafili and Seth Tauamiti. As part of their professional development, the wellbeing champions completed Le Va's Mental Wealth workshop and the introductory course in "NRL Wellbeing."

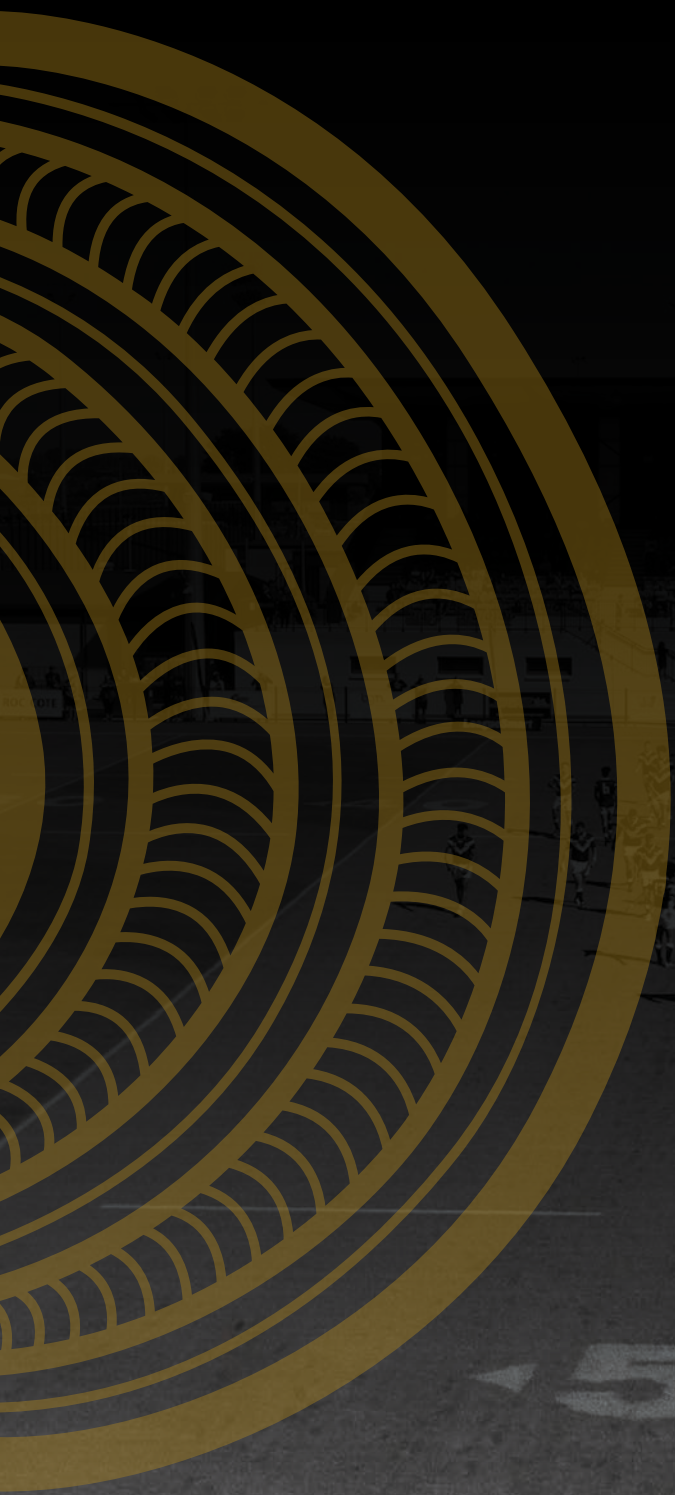

Note 1 - Reporting entity

New Zealand Rugby League Inc. (the “Controlling Entity”, also referred to as “the Society”) is a public benefit entity for the purposes of financial reporting in accordance with the Financial Reporting Act 2013.

These consolidated financial statements for the year ended 31 March 2022 comprise the controlling entity and its controlled entities (together referred to as the ‘Group’) and individually as ‘Group entities’.

Note 2 - Basis of preparation

(a) Statement of compliance

The consolidated financial statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice (“NZ GAAP”). They comply with Public Benefit Entity Accounting Standards Reduced Disclosure Regime (“PPE Standards RDR”) as appropriate for Tier 2 public benefit entities, for which all reduced disclosure regime exemptions have been applied.

The Group qualifies as a Tier 2 reporting entity as for the current and prior period the group is not publicly accountable and is not large (operations expenditure has been between \$2m and \$30m).

These financial statements were authorised for issue by the New Zealand Rugby League Board on 22 June 2022.

(b) Measurement basis

The consolidated financial statements have been prepared on a historical cost basis, except for revalued land and buildings.

(c) Functional and presentation currency

The financial statements are presented in New Zealand dollars (\$) which is the controlling entity’s functional and Group’s presentation currency, rounded to the nearest thousand dollars.

There has been no change in the functional currency of the Group during the year.

(d) Going Concern basis

The Group has made a profit for the year of \$1,204,000 (2021:\$1,004,000 before other comprehensive income).

The forecasts for the Society report a surplus. COVID-19 had an impact on the organisation in 2020/22, and it is expected that COVID-19 will continue to impact the business in 2022/23. The forecast revenue is also susceptible and sensitive to the risks that not all sponsorship and grant income can be reliably confirmed and that gate takings and prize money are reliant on attendance at events including Rugby League World Cup 2022.

Accordingly there is a possibility that actual results do not turn out as forecast.

Consideration has been given in the approved forecasts, to the on-going funding of the Society and its Zones, the business model under which the NZRL presently operates and the possible outcome of negotiations for additional grants and sponsorships. The potential effects of any further disruption from COVID-19 are being planned for, and mitigations are in place, however, the financial of these disruptions cannot currently be quantified.

At 22 June 2022 the Group had \$1,488,290 of funds remaining in its customised average rate facility with the Bank of New Zealand available to utilise, with a further bank overdraft facility of \$200,000 overdraft also available. As such, it is believed that the Group can operate within its existing bank facilities and is preparing the financial statements on a going concern basis.

Note 3 - Significant accounting policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements and have been applied consistently by the Group.
The significant accounting policies of the Group are detailed below:

(a) *Revenue*

Revenue is comprised of exchange and non-exchange transactions. Exchange transaction revenue arises when one entity receives assets or services, or has liabilities extinguished, and directly gives approximately equal value in exchange.

Non-exchange transaction revenue arises from transactions without an apparent exchange of approximately equal value. Non-exchange revenue includes grant, sponsorship and other revenue derived from activities that are partially funded by rates.

Revenue is recognised when the amount of revenue can be measured reliably and it is probable that economic benefits will flow to the Group, and measured at the fair value of consideration received or receivable.

The following specific recognition criteria in relation to the Group's revenue streams must also be met before revenue is recognised.

i. Revenue from exchange transactions

Coaching and development

Coaching and development revenue consists of revenue sourced from players' fees and levies. Revenue from these fees and levies will be recognised as the services associated are completed. Amounts received in advance for services to be provided in future periods are recognised as a liability until such time as the service is provided.

ii. Revenue from non-exchange transactions

Charitable trust grants, other grants and sponsorships

Revenue from grants and sponsorship is recognised when it becomes receivable unless there is an obligation to return the funds if conditions of the grant or sponsorship agreement are not met. If there is such an obligation, the grants are initially recorded as grants received in advance and recognised as revenue when conditions of the contract are satisfied.

Match revenue and New Zealand Racing Board

Match revenue and New Zealand Racing Board revenue is recognised when the amount of revenue can be measured reliably and it is probable that economic benefits will flow to the Group, and measured at the fair value of consideration received or receivable.

New Zealand Government COVID-19 Wage Subsidies

During the year ended 31 March 2022, the Group received \$43,200 (2021: \$416,000) from the New Zealand Government for the COVID-19 wage subsidies. The wage subsidies are not recognised until there is reasonable assurance that the Group will comply with the eligibility criteria attached to them and that the wage subsidies will be received. The wage subsidies are recognised in profit or loss, within other revenue, on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the wage subsidies are intended to compensate.

(b) Foreign currency transactions

Monetary assets and liabilities denominated in foreign currencies at the reporting date are retranslated to the functional currency at the exchange rate at that date. The foreign currency gain or loss on monetary items is the difference between amortised cost in the functional currency at the beginning of the year, adjusted for effective interest and payments during the year, and the amortised cost in foreign currency translated at the exchange rate at the end of the year.

Note 4 - Use of judgements and estimates

Judgements

In the process of applying the Group's accounting policies, management has made judgements, which have a significant effect on the amounts recognised in the consolidated financial statements.

Estimates and assumptions

The key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below. The Group based its assumptions and estimates on parameters available when the consolidated financial statements were prepared. Existing circumstances and assumptions about future developments however, may change due to market changes or circumstances arising beyond the control of The Group. Such changes are reflected in the assumptions when they occur.

Key assumptions and judgements relate to:

- Revenue recognition: non-exchange revenue - Management is required to make a judgement on the value received (where the revenue stream is not received in cash or is not easily measurable) and as to the existence of any conditions and restrictions. (Note 8)
- Going concern - Management is required to make a judgement on key inputs and assumptions to cash flow forecasts used to assess the Group as a going concern. (Note 2d)
- Revaluation of land and buildings - The Group's land and buildings were revalued at 31 March 2021 using an independent valuer. Management has judged that the revaluation method is more relevant than the cost method for the Society, as it ensures the carrying value of the land and buildings reflects the market/fair value of the assets as at 31 March 2022.

In estimating the fair value of land and buildings, the fair value method of valuation was used under PBE IPSAS 17 *Property Plant and Equipment*. The fair value method makes significant use of observable prices in active markets and recent market transactions on an arm's length basis. Management consider it appropriate to have the land and buildings revalued every 3 - 5 years.

Recognition and measurement

Property, plant and equipment are initially shown at cost or at fair value in the case where an asset is acquired at no cost or for a nominal cost, less accumulated depreciation and any impairment losses. Cost includes any costs that are directly attributable to the acquisition of the items including the costs of bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended.

Additions

The cost of an item of property, plant and equipment is recognised as an asset if, and only if, it is probable that future economic benefits or service potential associated with the item will flow to the Group and the cost of the item can be measured reliably.

Disposals

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount of the asset. Gains and losses on disposals are recognised in surplus or deficit.

Depreciation

Property, plant and equipment depreciation is based on the cost of an asset less its residual value.

Depreciation is recognised in surplus or deficit on a diminishing value basis over the estimated useful lives of each component of an item of property, plant and equipment. Land is not depreciated.

The diminishing value depreciation rates are:

- Buildings 2.0%
- Motor vehicles and Trailers 20% - 30.0%
- Plant and equipment 10.0% - 50.0%
- Furniture and fittings 10.0% - 16.0%

Depreciation methods, useful lives, and residual values are reviewed at reporting date and adjusted if appropriate.

Revaluation

Following initial recognition at cost, land and buildings are carried at re-valued amounts, which is the fair value at the date of the revaluation less any accumulated impairment losses. Fair value is determined by reference to market based evidence, which is the amount for which the assets could be exchanged between a willing buyer and a knowledgeable willing seller in an arm's length transaction as at the valuation date.

Any revaluation surplus is recognised in other comprehensive income and credited to the asset revaluation reserve in equity, unless the increase relates to a revaluation decrease of the same asset previously recognised in the profit or loss. Any revaluation deficit is recognised in other comprehensive income and debited to the asset revaluation reserve in equity to the extent of the revaluation reserve balance accumulated from previous year gains. When no revaluation reserve balance is available to offset a revaluation loss the revaluation deficit is reported within profit or loss for the year.

Revaluations are completed on an asset basis and movements are evaluated on an asset class basis. Upon disposal, any revaluation reserve relating to the particular asset being sold is reclassified to retained earnings.

Subsequent to revaluation, the building assets are depreciated based on their estimated useful lives.

i. Loans and receivables

Loans and receivables are financial assets with fixed or determinable payments that are not quoted in an active market.

Loans and receivables are subsequently measured at amortised cost using the effective interest method, less any impairment losses.

Loans and receivables comprise of cash and cash equivalents, and net recoverables from non-exchange transactions.

Cash and cash equivalents represent highly liquid investments that are readily convertible into a known amount of cash with an insignificant risk of changes in value, with maturities of 3 months or less.

ii. Amortised cost financial liabilities

Financial liabilities classified as *amortised cost* are non-derivative financial liabilities that are not classified as *fair value through surplus or deficit* financial liabilities.

Financial liabilities classified as *amortised cost* are subsequently measured at amortised cost using the effective interest method.

Financial liabilities classified as *amortised cost* comprise cash and cash equivalents (bank overdrafts), trade and other payables, and loans.

Trade and other payables are carried at amortised cost using effective interest method and due to their short-term nature they are not discounted.

All controlled entities have a balance date of 31 March.

There are no significant restrictions regarding to the transfer of loan repayments, and other funds from controlled entities.

The Zones have been established as the delivery mechanism of the national Game Plan working with Clubs and District Leagues. The Limited Partnership was established to create an entity to hold its land and building assets. These assets were subsequently mortgaged to the Bank of New Zealand to secure a new term loan.

For accounting and financial reporting purposes, the seven Zones and the Limited Partnership are considered to be subsidiaries of New Zealand Rugby League Inc.

Basis of consolidation

i. Controlled entities

Controlled entities are entities controlled by the Group, being where the Group has power to govern the financial and operating policies of another entity so as to benefit from that entity's activities. The financial statements of the Group's controlled entities are included in the consolidated financial statements from the date that control commences until the date that control ceases.

Subsequent changes in a controlled entity that do not result in a loss of control are accounted for as transactions with controllers of the controlling entity in their capacity as controllers, within net assets/equity.

ii. Transactions eliminated on consolidation

Intra-group balances and transactions, and any unrealised income and expenses arising from intra-group transactions, are eliminated in preparing the consolidated financial statements.

Unrealised losses are eliminated in the same way as unrealised gains, but only to the extent that there is no evidence of impairment.
