1 Overview

Thank you for using LAB Platform, a platform owned and operated by LAB Group Services Pty Ltd (**LAB**) that allows companies to streamline customer acquisition by providing digital onboarding solutions, electronic document and terms acceptance and electronic identity verification

Generally, we will process a LAB Platform user's personal information on behalf of one of our customers (**Customer**), who provide financial or investment products or services to end users.

Alternatively, an individual may have provided their information to us, such as if they have interacted with us on social media or contacted us directly.

Your privacy is important to us and we are committed to protecting your privacy in accordance with the Australian *Privacy Act 1988* (Cth) which includes the Australian Privacy Principles (**APPs**) and the New Zealand *Privacy Act 2020* which includes the Information Privacy Principles (**IPPs**), and any related privacy codes including the Personal Data Protection Act (PDPA).

This Policy outlines how we collect, use, disclose and store your personal information and lets you know how you can access that information. This Policy applies to our obligations when handling personal information in Australia and New Zealand.

Please read this Policy carefully and contact us using the details below if you have questions.

If you are a Customer, suppler, vendor or end user in the European Union, or the UK please see our attached GDPR Notice.

2 Consent

By accessing LAB Platform or otherwise providing personal information to us, where required you consent to us collecting, using, storing and disclosing your personal information in accordance with this Policy or as required or permitted by law. If you continue using our services, then we will treat your use as your consent to us handling your personal information in accordance with this Policy.

3 What kinds of personal information do we collect and hold?

The type of personal information we collect depends on the circumstances of its collection and the nature of your dealings with us.

If you are a customer or prospective customer of a company that is using LAB Platform in its customer acquisition process, this information may include:

- a. your name, email address and phone number;
- b. date of birth;
- c. gender;
- d. details of your employment, including the company you work for and your job title;
- e. your nationality and which countries you hold citizenship of;
- f. government identifiers, such as your Tax File Number or Medicare number (in Australia), or IRD number (in New Zealand);
- g. financial information, such as your credit history, transaction history;
- h. any photos that you upload, such as photo identification;
- your device ID, device type and information, geo-location information, Internet Protocol (IP)
 address, standard web log information browser session data, device and network information,
 statistics on page views, acquisition sources, search queries, browsing behaviour and information
 gathered through internet cookies; and
- j. information contained in any communications between you and us.

If you are a prospective employee or independent contractor applying to work with LAB, we may collect the following information:

- a. your name, address and contact details:
- b. business registration details, such as your Australian Business Number or New Zealand Business Number;
- c. your employment details and qualifications;
- d. billing and payment information; and
- e. any other personal information you provide to us as part of the recruitment process.
- f. For general users that may not use LAB Platform but interact with us in other ways, we may collect information when you connect with us or use our website. This may include information:
- g. provided in communications we have with you; and
- h. about your access and use of our website, including browser session data, device and network information, statistics on page views, acquisition sources, search queries, browsing behaviour and information gathered through internet cookies.

We do not collect sensitive information (as defined in the Australian Privacy Act 1988 (Cth)) from individuals.

If you choose not to provide information as requested, we may not be able to service your needs. For example, it will not be possible for us to provide you with our service if you want to remain anonymous or use a pseudonym.

We sometimes receive unsolicited personal information. In circumstances where we receive unsolicited personal information our policy is to destroy or de-identify the information as soon as practicable if it is lawful and reasonable to do so unless the unsolicited personal information is reasonably necessary for, or directly related to, our functions or activities.

4 Why do we collect your personal information?

We collect your personal information primarily to provide you with our customer acquisition service for any company that you interact with through LAB Platform and to enable your use of LAB Platform.

Some ways we use your personal information are:

- a. for the purpose for which the personal information was originally collected;
- b. to identify and interact with you;
- c. to conduct our business, including performing administrative and operational functions;
- d. to comply with any legal requirements, including any purpose authorised or required by law, or by a court or tribunal; and
- e. for any other purpose for which you give your consent.

In relation to the personal information of contractors, employees and prospective staff members, we collect personal information for purposes including to:

- a. enable us to carry out our recruitment functions;
- b. correspond with you;
- c. fulfil the terms of any contractual relationship; and
- d. ensure that you can perform your duties.

5 How we collect your personal information?

a. You give it to us

We collect personal information directly from you when you:

- a. use our Services, including LAB Platform;
- b. interact or share personal information with us via our platforms and social media; and
- c. otherwise communicate with or provide the information to us this may include recording telephone calls that we have with you.

We generally only communicate directly with our Customers and tend to only communicate directly with individuals if you contact us.

b. We collect it

We may also collect your personal information from third parties including:

- a. any company that you are interacting with through LAB Platform;
- b. service providers;
- c. referrals who may have referred you to us; and
- d. organisations with whom we have an agreement to share information with.

We will generally obtain consent from the owner of personal information to collect their personal information. Consent will usually be provided in writing; however, sometimes it may be provided orally or may be implied through a person's conduct. We endeavour to only ask for your personal information if it is reasonably necessary for the activities that you are seeking to be involved in.

6 Disclosing your personal information

We may disclose your personal information for the purposes outlined in this Policy to the following third parties:

- a. our customers who are using LAB Platform to streamline their customer acquisition process;
- b. our business or commercial partners whom we have an agreement to share information;
- c. other members of LAB's corporate group;
- d. our professional advisers, dealers and agents;
- e. third parties and contractors who assist us with our activities or provide services to us, including customer enquiries and support services, IT service providers, data storage, webhosting and server providers, marketing and advertising organisations, payment processing service providers;
- f. payment system operators and debt-recovery functions if you are a contractor;
- g. third parties to collect and process data, such as Amazon Web Services; and
- h. any third parties authorised by you to receive information held by us.

We may also disclose your personal information if we are required, authorised or permitted by law.

We may send information to third parties that are located outside of Australia and New Zealand. These third parties are located in the United States of America, the United Kingdom, the European Union, Singapore, India and the Philippines, although this list may change from time to time. Disclosure is made to the extent that it is necessary to perform our functions or activities and in accordance with the IPPs and APPs (to the extent applicable).

7 Using your personal information for direct marketing

If you work for a business that uses or may benefit from our services, we may use your personal information to contact you to promote and market our products and services in accordance with applicable laws.

You can opt-out from being contacted for direct marketing purposes by contacting us at enquiries@labgroup.com or by using the unsubscribe facility included in each direct marketing communication we send. Once we receive a request to opt out from receiving marketing information, we will stop sending such information within a reasonable amount of time.

For the avoidance of doubt, we will not contact Customers' end users for direct marketing purposes.

8 The Document Verification Service (DVS)

In using our services, you confirm that you are authorised to provide your identity details to us or the identity details of the person you may be assisting.

We will use your identity details to verify your identity and provide confidence in that verification to our clients, and:

- a. the information will be sent to the Australian DVS to match against records held by Commonwealth or state bodies (e.g. the passport office, your state driver licence authority or another relevant Commonwealth or state body that holds your data);
- b. our check to the Australian government or state records will involve LAB Group and Equifax.

In the document flow within the LAB Platform, you give your express consent to the collection, use and disclosure of your personal information that you have provided to us, including on a document.

Please note the following:

- a. We will use the DVS to verify your identity matches the records held at Commonwealth or state level:
- b. We must comply with our access agreements with the Attorney General's office and also the Privacy Act;
- c. Your rights are set out in this Privacy Policy, including the right to access your data, correct inaccurate data, complain about our processing to OAIC and withdraw your consent;
- d. If you do not consent, then we cannot verify your identity, and you will not be able to use our services. This may mean our clients have to try to verify your identity using another method;
- e. Our contact details are at the end of this Privacy Policy; and
- f. You can visit idmatch.com.au for more information about the DVS service.

9 Security

We will ensure that all personal information we hold is protected by such security safeguards as are reasonable in the circumstances against loss, unauthorised access, use, modification and disclosure or other misuse and will take all reasonable steps to protect personal information under our control from misuse, interference and loss and from unauthorised access, modification or disclosure. We hold your personal information electronically in secure databases operated by our third-party service providers.

We protect the personal information we hold through encryption, firewalls and login password protocols, secure and access-controlled premises, monitoring staff access, auditing and network segregation for sensitive information store electronically.

While we take reasonable steps to ensure your personal information is protected from loss, misuse and unauthorised access, modification or disclosure, security measures over the internet can never be guaranteed.

We encourage you to play an important role in keeping your personal information secure, by maintaining the confidentiality of any passwords and account details used on our website.

10 Accessing or correcting your personal information

If you would like to access your personal information, please contact us using the details below. In certain circumstances, we may not be able to give you access to your personal information in which case we will write to you to explain why we cannot comply with your request.

We try to ensure any personal information we hold about you is accurate, up-to-date, complete and relevant. If you believe the personal information we hold about you should be updated, please contact us using the details below and we will take reasonable steps to ensure it is corrected, having regard to the purpose for which the information is held and may lawfully be used.

11 Destroying or de-identifying personal information

We destroy or de-identify personal information when we no longer need it, unless we are otherwise required or authorised by law to retain the information.

12 Making a complaint

If you believe your privacy has been breached or you have a complaint about our handling of your personal information, please contact us using the details below.

We take privacy complaints seriously. If you make a complaint, we will endeavour to respond within 5 working days to acknowledge your complaint. We will try to resolve your complaint within 2030 working days. When this is not reasonably possible, we will contact you within that time to let you know how long we will take to resolve your complaint. We will investigate your complaint and write to you to explain our decision as soon as practicable. If you are not satisfied with our decision, you can refer your complaint as follows:

- If you are based in Australia, you can refer your complaint to the Office of the Australian Information Commissioner by phone on 1300 363 992 or online at www.oaic.gov.au.
- If you are based in New Zealand, you can refer your complaint to the New Zealand Privacy Commissioner by phone on 0800 803 909 or online at www.privacy.org.nz.

13 Changes

We may, from time to time, amend this Policy. Any changes to this Policy will be effective immediately upon the posting of the revised Policy on our website. By continuing to use the services following any changes, you will be deemed to have agreed to such changes. We recommend you visit this site from time to time to keep up to date with any changes.

GDPR Privacy Notice

1 Overview

LAB Group Services Pty Ltd (collectively, LAB, we, us, our) is committed to protecting your privacy.

We have prepared this GDPR Privacy Notice to describe to you our practices regarding personal information we collect from users of our services, including our LAB Platform service, website at www.labgroup.com, and all other services provided by LAB (**Services**).

This GDPR Privacy Notice describes the processing of your personal information that we carry out as data controller, to the exclusion of the processing of your personal information which we carry out as data processor on behalf and as per the instructions of our customers, who provide financial or investment products or services to an end user (**Customers**).

For further information regarding the processing of your personal information in that context, an end user should refer to the relevant Customer's privacy policy.

Our primary privacy obligations are derived from Australian law. Our Privacy Policy, available on our websiteabove, sets out how we comply with these obligations. Sometimes, w, here we also handle the information of EU citizens or share data with other organisations which do so or provide services to individuals located in the EU. To the extent that we do so, this GDPR Privacy Notice for EU General Data Protection Regulation applies.

The processing of Personal Information under this GDPR Privacy Notice will always be in line with the Australian Privacy Principles contained in the *Privacy Act 1988* (Cth), the General Data Protection Regulation (**GDPR**), and in accordance with data protection regulations that are applicable to LAB.

We have implemented a number of technical and organisational measures to ensure the most complete protection of protect your Personal Information personal information processed through the Services.

2 Your rights

a. The GDPR provides you with the following key rights, being the right to:

- Be informed: anyone processing your personal information must make clear what they are processing, why and who else the data may be passed to.
- Access: the right to obtain from us confirmation as to whether or not personal data information concerning you is being processed and to access what data personal information is held about you.
- Rectification: the right to have your personal information corrected or amended if what is held is incorrect, and to have incomplete data completed.
- Erasure: the right to ask for your personal data information to be deleted, also known as the right to be forgotten, if permitted under applicable laws.
- Restrict processing: the right to require a temporary halt to the processing of personal information.
- Data portability: the right to request for any data personal information supplied by you to us to be provided in a structured, commonly used and machine-readable format.
- Object: the right to object, on grounds relating to your particular situation, at any time to the processing of your data personal information by us, including the right to object upon request and free of charge to the processing of your personal data information for direct marketing purposes.
- Consider automated decision making and profiling: the right not to be subject to a decision based solely on automated processing.
- · Withdraw your consent: this right to withdraw your consent at any time when the processing of

your personal information is based on your consent, without affecting the lawfulness of processing based on your consent before its withdrawal.

• Lodge a complaint: right to lodge a complaint with a competent supervisory authority in particular in the EU/EEA Member State of your habitual residence, place of work or of an alleged infringement of the GDPR. A list is available here.

These rights are subject to the conditions and limitations under the GDPR and applicable national data protection laws.

This GDPR Privacy Notice sets out, among other things, how you can exercise these rights when dealing with LAB.

3 Legal Bases for the processing

a. We process your personal information on one of the following legal bases:

- The processing of your personal information is necessary for the performance of the contract or to take steps prior to entering into a contract between us and you (Article 6(1)(b) GDPR)
- The processing of personal information is necessary for compliance with a legal obligation to which we are subject (Article 6(1)(c) GDPR)
- The processing of personal information is necessary for the purposes of the legitimate interests pursued by us or by a third party and those interests are not overridden by your interests and fundamental rights and freedoms (Article 6(1)(f) GDPR). Our legitimate interests include: Administering and managing our relationship with you, including account setup, customer support, and contract execution; ensuring compliance with legal and regulatory requirements, including record retention and security measures; preserving system security and integrity by monitoring audit logs, system communications, and other security-related activities; supporting business operations such as reporting, audits, due diligence for mergers and acquisitions, and internal governance; and exercising or defending legal claims.
- In specific circumstances, the processing of your personal information can be based on your freely given consent (Article 6(1)(a) GDPR).

b. When processing special categories of personal data concerning you, we rely on one of the following grounds:

- Your explicit consent (Article 9(2)(a) GDPR)
- The processing relates to personal information which are manifestly made public by you (Article 9(2)(e) GDPR)
- The processing is necessary for the establishment, exercise or defence of legal claims (Article 9(2)(f) GDPR).

If you believe that consent has not been given freely or in breach of the terms of this Privacy Notice, please contact us using the details below.

4 Personal Information we collect

We will only collect Personal Information from you which is adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed.

Personal Information means any information relating to you as an individual and that identifies you or allows someone to identify you (whether directly or indirectly), including, for example, your name, telephone number, e-mail address, date of birth, as well as any other non-public information about you that is associated with or linked to any of the foregoing data.

4.1 Information you provide to us

a. Account and User Content

During your use of the Services, you may provide your personal information on forms or provide us with additional content.

We may collect Personal Information from you, such as:

- · your name, email address and phone number;
- · date of birth:
- your nationality and which countries you hold citizenship of;
- details of your employment, including the company you work for and your job title;

This data is used to enable us to identify and verify you and provide you with support, services, mailings, sales and marketing actions.

Certain functionality of the Services requires your Personal Information to function properly.

When you create or share content, or upload content such as photos, comments, meta data (geographic tags) we may also collect this data.

The legal bases for this processing are (see section 3 above for further details):

- the Personal Information being necessary for the performance of a contract to which you are a party;
- for carrying out pre-contractual measures;
- our legitimate interests; and/or
- your consent (it being noted that you may withdraw it at any time as explained).

b. Contact Data

If you provide us feedback or contact us via e-mail, or other means including by phone call or by contracting with us, we will collect your name and e-mail address, as well as any other content included in the e-mail or conversation, in order to send you a reply. We will store and process your communications and information to the extent necessary and in accordance with this privacy notice. We may also collect contact information if you choose to upload, sync or import it from a device.

The legal bases for this processing are (see section 3 for further details):

- the Personal Information being necessary for the performance of a contract to which you are a party;
- for carrying out pre-contractual measures; and/or
- our legitimate interests.

c. Subscription Data

When you use the Services, you may have the ability to subscribe to our newsletters or other forms. We may collect the data when you input your details for subscription purposes.

The Personal Information is processed for the purpose of informing you regularly by means of a newsletter or other offer form. The personal information collected during the subscription will only be used for marketing materials or for reasons made known on the form.

The legal basis for this processing are (see section 3 for further details):

- · your consent (it being noted that you may withdraw it at any time); and/or
- our legitimate interests.

When submitting the form and voluntarily providing us with your data, you will also be requested to provide your consent to the use of such data by us for the purpose of providing subscription based materials. For the purpose of revocation of consent there is a corresponding unsubscribe link found in each subscription email. You also contact us at enquiries@labgroup.com.au to revoke your consent. Please review the consent section above in this Privacy Notice for how we deal with consent. Where we use your data for direct marketing, we will ensure that it is in compliance with relevant laws.

Where you are our Customer a customer of ours, we may be required to send you emails for the management of our contractual relationship and other legitimate reasons including but not limited to billing, reminders and account verification.

d. Other Data

We may also collect Personal Information at other points on our Services which we will provide you with informed notice in accordance with the GDPR for such processing.

4.2 Information we collect as you use our services

a. Meta Data including Location Data

Some of our Services (including LAB Platform) may allow you to add or may have metadata added to your content including hashtags (to mark keywords), comments or other data. This helps our Services and your content to be more searchable.

We use location data to help target and tailor the Services to your particular location and jurisdiction. With your consent, we may also collect information about your precise location using methods including GPS, wireless networks, cell towers, Wi-Fi access points and other sensors.

The legal bases for this processing are (see section 3 above for further details):

• your consent (it being noted that you may withdraw it at any time).

b. Log Data

To make our Services more useful to you, our servers (which may be hosted by a third-party service provider) gather information automatically and store it in log files. This information includes Internet Protocol (**IP**) addresses, browser type and language, Internet service provider (**ISP**), referring and exit websites and applications, operating system, date/time stamp, and clickstream data.

We use this information to understand and analyse trends, to administer the Services, to learn about user behaviour regarding the Services, to improve our product and services, and to gather demographic information about our user base as a whole. LAB may use this information in our marketing and advertising services.

In some of our email messages, we use a "click-through URL" linked to content on our Services. When customers click one of these URLs, they pass through a separate web server before arriving at the destination page on our website. We track this click-through data to help us determine interest in particular topics and measure the effectiveness of our customer communications. You will be asked to provide your consent to such tracking before it takes place, and may withdraw it at any time as explained below.

The legal basis for this processing is:

- your consent; and/or
- our legitimate interests.

Please refer to our attached cookie policy for further details regarding our use of cookies and similar technologies.

c. Analytics

We use third party analytics tools to collect information anonymously and report website trends without identifying individual visitors. These tools collect information sent by your device or our Services, including the web pages you visit, add-ons, and other information that assists us in improving the Services.

The legal basis for this processing is your consent (it being noted that you may withdraw it at any time).

4.3 Information we collect from others

a. Data and content other people upload

We may also collect information and communications that other people provide when they use our Services. This can include information about you such as when others send messages, documents and information to you. We may also collect your information if you are invited to participate in our Services. This may include information such as your name, phone number and email address relevant to the Services and is used for the purpose of enabling us to provide our Services to you.

5 How we use your Personal Information

5.1 Use of personal information

We will only use or disclose your personal information for the purposes for which we advised you we were collecting it for as noted in this GDPR Privacy Notice and including to:

- enable you to access and use LAB Platform, our website and associated applications;
- maintain internal records and administrative purposes;
- to comply with our legal obligations and resolve any disputes that we may have;
- · maintain your account and contact details;
- remember information so you don't have to re-enter it during your visit or the next time you visit the Service;
- · provide personalised content and information to you and others;
- · send marketing communications to you;
- conduct our business, generate content and provide customer support and payment options (including updates and improvements);
- administer contracts including to negotiate, execute and/or manage a contract with you;
- communicate with you;
- provide you with access to protected areas of the website or other Services;
- · conduct surveys to determine use and satisfaction;
- detect, investigate and prevent potentially unlawful acts or omissions or acts or omissions with the
 potential to breach our Terms and Conditions, this Privacy Notice or any other policy;
- enforce our Terms and Conditions, this Privacy Notice or any other policy;
- · verify information for accuracy or completeness;
- · comply with our legal obligations;
- monitor metrics;
- combine or aggregate your personal information with information we collect from third parties and use it for the purposes set out in this Privacy Notice;

- protect a person's rights, property or safety;
- process transactions to which you are a party;
- resolve disputes and to identify, test and resolve problems;
- · improve our Services; and
- any other purpose made known in this Privacy Notice or other policy in accordance with applicable laws.

We agree to not use or disclose this information for any other purpose unless you consent to us doing so, or another exception applies under applicable laws.

In particular, we may use or disclose your personal information if we are required to do so by law or a court / tribunal order, or if we reasonably believe that the use or disclosure of the information is necessary for an enforcement related activity or on behalf of an enforcement body, to the extent permitted under applicable laws.

5.2 Creation of anonymous data

We also collect data in an anonymous form that does not permit association with any specific individual. We may collect, use, transfer, and disclose anonymous non-personal information for improvement of our services, subject to applicable law.

We may collect information regarding customer activities on our Services including the website. Subject to your prior consent where required under applicable law, this information is aggregated and used to help us provide more useful information to our customers and to understand which parts of our website, products, and Services are of most interest. Aggregated data is fully anonymised and therefore considered non-personal information for the purposes of this Privacy Notice.

2 Disclosure of your Personal Information

We may disclose your Personal Information to third parties for the purposes contained in this Privacy Notice, either on our own behalf or on behalf of our Customers, including:

a. Service Providers

We may share your Personal Information with service providers to:

- provide you with the Services that we offer you;
- to conduct quality assurance testing;
- to facilitate creation of accounts;
- to provide technical support;
- and/or to provide other services to LAB.

The service providers (and if necessary, data processors) include:

- information technology service providers such as web host providers and analytical providers;
- mailing houses;
- advertising partners;
- market research organisations to enable them to measure the effectiveness of our advertising;
 and
- specialist consultants.

These third party service providers are required must not to use your Personal Information other than to provide the services requested by LAB.

We may share your Personal Information with such third parties subject to obligations consistent with this GDPR Privacy Notice and any other appropriate confidentiality and security measures, and, where these parties qualify as data processors, on the condition that the third parties use your Personal Information only on our behalf and pursuant to our instructions.

We will take reasonable steps to ensure that anyone to whom we disclose your personal information respects the confidentiality of the information and abides by the GDPR or equivalent privacy laws.

b. Affiliates and Acquisitions

We may share some or all of your Personal Information with any of our parent companies' subsidiaries, joint ventures, or other companies under a common control (**Affiliates**), in which case we will require our Affiliates to honour this GDPR Privacy Notice. In the event we are involved in a merger, acquisition or sale of assets we may disclose Personal Information collected by us to such entities that we propose to merge with or be acquired by and will assume the rights and obligations regarding your Personal Information as described in this Privacy Notice. This includes the disclosure of information to our Customers where we act as a data processor.

c. Third parties including those you choose to share your data with

We may disclose your Personal Information to third parties to whom you expressly ask to us to send the Personal Information to or to third parties you choose to send your Personal Information to. This includes to the Customers that you interact with through LAB Platform.

We may also, with your consent or at your direction, disclose your personal information to your authorised representatives.

d. Other disclosures

Regardless of any choices you make regarding your Personal Information (as described below), LAB may disclose Personal Information if it believes such disclosure is necessary:

- a. in connection with any legal investigation;
- b. to comply with relevant laws, regulations, enforceable governmental requests or to respond to subpoenas or warrants served on LAB;
- c. to protect or defend the rights or property of LAB or users of the Services;
- d. to investigate or assist in preventing any violation or potential violation of the law, this Privacy Notice, or our Terms and Conditions;
- e. to protect the safety of any person or to protect the safety or integrity of our platform including for security reasons; or
- f. detect, prevent or otherwise address fraud, security or technical issues.

We will not share, sell, rent or disclose your personal information in ways different from what is disclosed in this GDPR Privacy Notice.

3 If we can't collect your data

If you do not provide us with the personal information described above, some or all of the following may happen:

- we may not be able to provide our Services to you, either to the same standard or at all;
- we may not be able to run the competitions and promotions in a way that benefits you;
- we may not be able to provide you with information about products and services that you may want; and/or
- we may be unable to tailor the content of our Services to your preferences and your experience of our Services may not be as enjoyable or useful.

4 Cookies Policy

5.3 What are cookies?

5.4 Use of cookies

a decision of the European Commission determining that such state provides an adequate level of data protection ("adequacy decision").

for states that are not covered by an adequacy decision (namely Australia and Singapore), appropriate safeguards in accordance with applicable laws, including by entering into the European Commission's Standard Contractual Clauses or other appropriate safeguards under Art. 46 GDPR.

derogations for specific situations in accordance with applicable laws, in particular when you have given your explicit consent to the data transfer, after having been informed of the possible risks of such transfers for the data subject due to the absence of an adequacy decision and appropriate safeguards.

9 Automated individual decision-making, including profiling

Where we use or disclose your Personal Information, we will also ensure that your Personal Information is relevant.

We will retain your Personal Information for the period necessary to fulfil the purposes outlined in this GDPR Privacy Notice unless a longer or shorter retention period is required or permitted by law. For example, when we process your Personal Data for the purpose of managing your account or profile, we may maintain the data as long as your account/profile is active.

When we process your data for direct marketing/subscription purposes, we will delete your Personal Data within three (3) years following your last interaction with us. Regarding personal data automatically collected about you on the Website, please refer to our attached Cookie Policy. Regardless of the processing of your Personal Data for the time strictly necessary to achieve these purposes, your Personal Data will then be retained for the period for which we may be held liable as a result of such processing, in accordance with applicable law. For example, when we process your data to manage your orders and our contracts, we may keep your personal data for up to ten (10) years after termination of our contractual relationship.
