1. Introduction

This Privacy Policy explains how TeemantSoft OÜ ("TeemantSoft," "we," "our," or "us") collects, uses, shares, and safeguards personal information of users located outside the European Economic Area (EEA), the United Kingdom, and Switzerland. If you are located in those regions, please refer to our dedicated GDPR Privacy Policy.

This policy applies to your use of TeemantSoft's services, including AI-powered assistants (such as Gemma, Opal, and Flint), web-based interfaces, mobile platforms, and integrations through communication platforms like WhatsApp, Microsoft Teams, and Google Chat.

2. Information We Collect

We may collect the following types of personal information:

- **Identification and contact details** (e.g., name, email address, phone number, job title, language preference).
- **Interaction data** (e.g., messages or inputs submitted during interactions with our AI agents).
- **Device and technical data** (e.g., IP address, browser type, device ID, time zone, cookies, and usage logs).
- **Third-party data** (e.g., information submitted about others, such as emergency contacts or witnesses, subject to your local regulations).
- **Document or media uploads processed** via OCR services.

3. How We Use Your Information

We use your personal data to:

- Deliver and improve our services and features.
- Enable and personalize your interactions with our AI agents.
- Provide customer and technical support.
- Monitor system integrity, detect fraud, and ensure security.
- Comply with legal and contractual obligations.

4. Sharing Your Data

We may share your data with trusted service providers strictly for operational and technical purposes:

- AI Processing: OpenAI, Mistral AI
- Messaging Infrastructure: Meta (WhatsApp), Google (Chat), Microsoft (Teams), Infobip
- Hosting and Storage: ScaleWay, Microsoft Azure
- OCR & Document Processing: Mistral OCR, Microsoft

These providers are contractually obligated to protect your data and only use it in accordance with our instructions.

5. International Transfers

Your data may be transferred and processed in countries outside your own. When doing so, we implement appropriate safeguards such as:

- Encryption and access controls
- Processor due diligence and contractual protections

6. Data Retention

We retain your personal data as long as it is necessary for the purposes outlined in this policy. This generally means:

- Account and user information: active period + 12 months
- Interaction data: up to 6 months
- Support requests: 2 years
- OCR data: not stored after processing

7. Your Rights

- Depending on your location, you may have rights to:
- Request access to your data
- Request correction or deletion of your data
- Withdraw consent where applicable
- Object to certain data processing activities
- File a complaint with your local data protection authority
