3. Use of Cookies

Our Site uses cookies to improve your browsing experience and analyze traffic.

a. Types of Cookies

- Essential cookies: Required for website functionality.
- Analytics cookies: Used by Google Analytics to understand user behavior.
- Preference cookies: Remember your settings and choices.

b. Cookie Consent

We use **Cookie Control** to manage your cookie preferences. When you visit our Site for the first time, a cookie banner will appear allowing you to **accept**, **reject**, or **customize** your cookie preferences.

You can change your preferences at any time through the Cookie Control settings on our Site.

4. How We Use Your Information

We may use your personal data to:

- Respond to inquiries or provide requested information.
- Send marketing communications (with your consent).
- Improve our website, content, and user experience.
- Comply with legal obligations.

We do not sell or rent your personal information to third parties.

5. Legal Basis for Processing (EU Visitors Only)

If you are located in the European Economic Area (EEA), we process your personal data based on one or more of the following legal bases:

- **Consent:** You have given us permission to use your data.
- Contract: Processing is necessary for fulfilling an agreement with you.
- **Legitimate Interest:** For website operation, analytics, and marketing (balanced with your rights).
- Legal Obligation: To comply with laws or regulations.

6. Data Retention

We retain personal information only for as long as necessary to fulfill the purposes outlined in this Policy or as required by law.

Google Analytics data may be retained for up to 26 months unless otherwise adjusted.

7. Sharing of Information

We may share your information with trusted third-party service providers who assist in operating our website or conducting business, such as:

- Webflow, our hosting platform
- Google Analytics, for website analytics
- Email marketing providers (if applicable)

These providers are required to protect your data and only use it for the purposes we specify.

8. International Data Transfers

If you are located in the European Union, please note that your data may be transferred to and processed in the **United States** or other countries where data protection laws may differ.

We take steps to ensure your information is protected, such as using standard contractual clauses approved by the European Commission.

9. Your Rights
