#### What is Lyrium?

Lyrium is a privacy-focused cryptocurrency that puts you in control. Built on the proven CryptoNote protocol, Lyrium enables fast, private, and untraceable transactions while maintaining true decentralization through Proof-of-Work mining.

One-minute confirmations. Private by default. Fair for everyone.

## Why Lyrium?

**Privacy First:** Ring signatures and stealth addresses keep your transactions private. No one can trace your spending or link your transactions.

**Fair Mining:** ASIC-resistant algorithm means anyone can mine with regular CPUs and GPUs. No specialized hardware monopolies.

**True Decentralization:** No pre-mine (except transparent 4% genesis allocation for development), no masternodes, no corporate control.

**Fast Confirmations:** 60-second blocks mean your transactions confirm quickly without sacrificing security.

**Long-Term Security:** Perpetual tail emission ensures miners are always incentivized to secure the network, even after initial supply distribution.

### **Genesis Block Allocation Program**

The 4% genesis allocation (20 billion LYR) funds development and is distributed through a three-tier ICO:

Tier	Price per LYR	Allocation	Bonus
Tier 1 - Genesis	\$0.0012	10B LYR	Up to 100%
Tier 2 - Expansion	\$0.0024	6B LYR	Up to 70%
Tier 3 - Final	\$0.00422	4B LYR	Up to 60%

Volume bonuses reward larger purchases with additional bonus blocks.

**Distribution:** All purchases will be airdropped to buyers when the web wallet launches in Q1 2026.

#### Roadmap at a Glance

Q4 2025: Mainnet launch, ICO begins

Q1-Q2 2026: Web wallet launch + airdrops, Node Box hardware, Tier 1 mining access

Q3 2026: Open-source release, public mining begins

Q3-Q4 2026: Desktop/mobile wallets, exchange listings

2027+: On-chain governance, zero-knowledge enhancements

- 40% Core development and infrastructure
- 25% Liquidity provision and exchange listings
- 20% Marketing and community growth
- 10% Legal compliance and operations
- 5% Reserve fund
