A strategy relying on time-tested models

- A stock-picking strategy that adapts to evolving market environments, based on three criteria: Price Momentum (outperformance relative to the benchmark index), Earnings Momentum (revision of earnings forecasts by analysts), and Momentum optimized by Artificial Intelligence (proprietary Machine Learning model).
- Implementation across very broad and All Cap investment universes: a minimum of 150 positions and 1,500 investment cases revisited monthly for Chahine Funds – Equity Europe.

Chahine Funds is a range of liquid and diversified portfolios, aiming for outperformance⁽¹⁾ relative to equity markets over the long term. Since the investment process is subject to strict and disciplined risk control, our portfolios offer a return/risk profile that is complementary to that of discretionary investment funds.

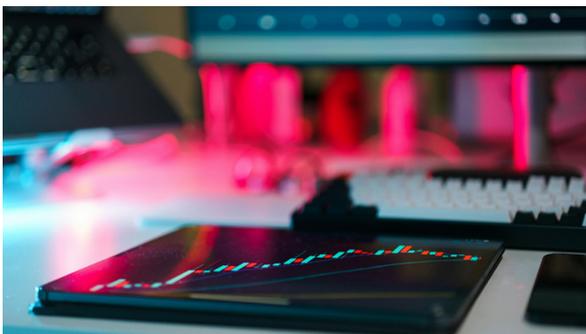
Investment processes enhanced through continuous research

A broad spectrum of complementary bond solutions

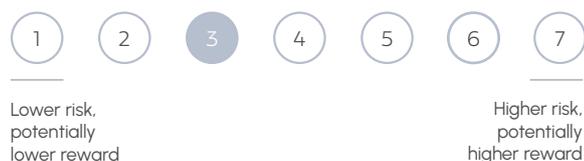
