The service is applicable for sites on the territory of the regions of Varna, Ruse, Dobrich, Shumen, Targovishte, Razgrad, Veliko Tarnovo, Silistra and Gabrovo.

\* If the installation of a given site does not allow consumption to be measured with a single device, the monthly fee for that site shall be increased by the specified amount for each additional measuring device installed for the service.
