## 3. Personal data we process

Depending on the services provided, we may process the following categories of personal data:

- Name, address, place of residence
- Date and place of birth
- Nationality and civil status
- Passport and identity document details
- BSN (Citizen Service Number), where legally required
- Contact details (email, telephone)
- Employment, income and education data
- Immigration and residence history
- Family composition and relationship data
- Legal, administrative and procedural data
- Correspondence with authorities
- Payment and invoicing details

Special categories of personal data (e.g. medical data) are processed only where strictly necessary and on a lawful basis.

# 4. Purpose of processing

We process personal data for the following purposes:

- Providing immigration, relocation and expat services
- Preparing and submitting applications to authorities
- Advising on residence, visa and legal procedures
- Communication with clients and authorities
- Performing contractual obligations
- Invoicing and financial administration
- Compliance with legal and regulatory obligations
- Defending legal claims or disputes

### 5. Legal basis for processing

Personal data is processed on one or more of the following legal grounds:

- Performance of a contract
- Compliance with a legal obligation
- Explicit consent of the data subject (where required)
- Legitimate interest, such as legal defense or business continuity

# 6. Sharing of data with third parties

Personal data may be shared with:

- Dutch and foreign government authorities (e.g. IND, embassies, municipalities)
- Courts and legal institutions
- Examination institutes
- Translators, notaries and legalisation services
- IT service providers (secure systems only)

Data is shared **only when necessary and only for the intended purpose**.

#### 7. Data transfers outside the EU

If personal data is transferred outside the European Economic Area, this will take place only where:

- the receiving country offers an adequate level of protection, or
- appropriate safeguards (such as standard contractual clauses) are in place.

# 8. Data retention periods

Personal data is retained no longer than necessary for the purpose for which it is processed.

In general:

- Client files are retained for at least 7 years (legal and fiscal obligation);
- Immigration files may be retained longer where legally required;
- Data is securely deleted once retention is no longer required.

- Right of access
- Right to rectification
- Right to erasure (where legally possible)
- Right to restriction of processing
- Right to data portability
- Right to object to processing
- Right to withdraw consent at any time
