As a resident, you will be automatically enrolled in the Property Damage Liability Waiver Program upon signing your lease unless you opt out. This ensures you meet the \$100,000 property liability coverage requirement in your lease.

## What the Program Includes\*



Under the Program, your Property waives your financial responsibility for the property damage you negligently cause to your apartment from one of the following causes of loss: fire, smoke, explosion, and water discharge and overflows. The Program does not result in the waiver of your liability to parties other than your Property. Other types of liability or causes of loss, such as bodily or personal injury or property damage caused by weather events, including but not limited to flooding, are not included in the Program. Reimbursement for personal contents damage and displacement costs are on a per incident basis, not per enrolled resident, and are payable only to the extent you caused less than \$100,000 damage to your apartment. - ✓ Minimum of \$100,000 in Liability Coverage
- ✓ Resident's Insured Address  
Be sure to include unit number/letter.
- ✓ [Property Name] MUST Be Included  
as an Additional Interest/Interested Party  
and the address for "Notification of Changes"  
to your policy must appear as follows:


